SUBJECT: ADOPTING OF A RESOLUTION ADMENDING THE STANDARDS AND TRAINING FOR CORRECTIONS (STC) GRANT FOR THE TOTAL AMOUNT OF \$13,200 AND AMENDING THE FY 2019-20 OPERATING BUDGET

RECOMMENDATION:

It is recommended that the City Council adopt the following resolution:

RESOLUTION NO. 2019-114 - A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA AMENDING THE STANDARDS AND TRAINING FOR CORRECTIONS (STC) GRANT AND AMENDING THE FY 2019-20 OPERATING BUDGET BY RECEIVING AND APPROPRIATING \$6,200 IN STC GRANT FUNDS

It is recommended that the City Council take the following actions:

- 1) Amending the FY 19-20 Standards & Training for Corrections (STC) Grant award from \$7,000 to \$13,200;
- 2) Accepting \$6,200 of additional grant funds from the FY 19-20 STC Grant;
- 3) Amending the FY 2019-20 Operating Budget by receiving and appropriating an additional \$6,200 in STC Grant funds; and,
- 4) Authorizing the City Manager, or designee, to execute any and all agreements on behalf of the City, in substantially the form submitted, subject to review and approval as to form by the City Attorney.

EXECUTIVE SUMMARY:

Approval of the Proposed Resolution (Attachment 1), staff anticipated to receive and budgeted for \$7,000 for the FY 2019-20 STC grant, however on July 15, 2019, the City was awarded a total of \$13,200 by the Board of State Community Corrections (Attachment 2). An increase of \$6,200 in needed to meet the grant expenditure requirements and meet our annual goals for state required training/certifications.

FISCAL IMPACT:

Accept FY 2019-20 STC Grant Page 2 of 2 – August 5, 2019 The fiscal impact is neutral due to an increase in STC Grant funds revenue of \$6,200 (215-2090-40873-58691) with a corresponding increase to expenditures of \$6,200 (215-2090-XXXXX-58691).

PREVIOUS RELATED ACTION:

The City Council approved an appropriation of the STC Grant on November 19, 2018 in the 1st Quarter Budget Review, and Adoption of Resolutions Amending the Fiscal Year 2018-2019 Operating Budget and Personnel Actions.

ENVIRONMENTAL IMPACT: N/A

DISCUSSION:

The Police Department has been awarded a one-year Standards and Training for Corrections (STC) Grant in the amount of \$13,200 to meet State required training (Attachment 2). The grant period is July 1, 2019 through June 30, 2020. Funds will be disbursed on a quarterly basis.

The Standards and Training for Corrections (STC) program, is a division of the Board of State and Community Corrections (BSCC). The purpose of the STC program is to provide funding to meeting State required training/certification requirements for Police Staff. The program accomplishes this by developing selection and training standards, providing a course certification and training support. In addition, participating agencies are allocated funding through the STC program.

As such, staff is recommending an increase in revenue estimates of \$13,200 and a corresponding increase in expenditures for the STC grant to cover staff training and overtime for FY 2019-20, are therefore requested:
