

**RESOLUTION NO. 2019-117**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE BAIL (FINE) SCHEDULE FOR PARKING AND NON-MOVING VEHICLE VIOLATIONS OCCURRING IN THE CITY OF POMONA**

**WHEREAS**, California Vehicle Code Section 40203.5 provides for local jurisdictions to set bail (fine) schedules for parking and non-moving vehicle violations with conformity, to the extent possible, to bail (fine) schedules of other jurisdictions within the same county;

**WHEREAS**, the City of Pomona's current bail schedule needs to be updated to include additional California Vehicle Code (CVC) parking and non-moving violations that are punishable by a civil penalty, and set the penalty amounts;

**WHEREAS**, the proposed bail (fine) schedule adds several CVC violations and the penalty for each and also includes penalty increases for certain other violations, to bring them consistent with the penalties charged by other jurisdictions based on a current City survey;

**WHEREAS**, all penalties on the City's Bail (Fine) Schedule include State mandated surcharges of \$12.50 on each paid parking citation, 50% of registration and equipment violations and \$2 on each \$10 for Handicap State Linkage Fee, which are remitted to the State for allocation to various State and County Court funds; and

**WHEREAS**, pursuant to the authority generally granted by to the City Council by the Pomona City Charter, and pursuant to the authority given local agencies by Section 40203.5 of the California Vehicle Code, the City Council desires to adjust the bail (fine) schedule for parking and non-moving vehicle violations.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona, California, as follows:

**SECTION 1.** That the Bail (Fine) Schedule for Parking and Non-Moving Vehicle

Violations of the Pomona City Code, Pomona Zoning Ordinance and the California Vehicle Code is hereby amended as set forth in Exhibit A attached hereto and incorporated herein by this reference.

**SECTION 2.** The Bail (Fine) Schedule for Parking and Non-Moving Vehicle Violations approved by this action shall become effective beginning August 15, 2019.

**SECTION 3.** The City Clerk shall certify to the passage and adoption of this resolution, and it shall thereupon take effect and be in force.
