

RESOLUTION NO. 2019-124

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FY 2019-20 CAPITAL IMPROVEMENT PROGRAM BUDGET BY APPROPRIATING \$41,000 OF AVAILABLE SERIES “BI” (“AW”) BONDS AND RE-APPROPRIATING \$259,468 OF PROP A FUNDS FROM “MAJOR STREET REHABILITATION – CITYWIDE (FY 13-14 TO FY 15-16),” PROJECT NO. 428-2590-XXXXX-68548 TO “POMONA TRANSIT BRIDGE IMPROVEMENTS AND BEAUTIFICATION,” PROJECT NO. 428-2590-XXXXX-67927

WHEREAS, the FY 2019-20 Capital Improvement Program (CIP) Budget for “Pomona Transit Bridge Improvements and Beautification,” Project No. 428-2590-XXXXX-67927, is currently funded in the amount of \$1,525,116 with Prop A Funds and Series “AW” Bonds (Mission Promenade Sale Proceeds); and

WHEREAS, “Major Street Rehabilitation – Citywide (FY 13-14 to FY 15-16),” CIP project No. 428-2590-XXXXX-68548 has available Prop A funds in the amount of \$259,468 and no further Prop A eligible work for the, “Major Street Rehabilitation – Citywide (FY 13-14 to FY 15-16),” project ; and

WHEREAS, the City Council desires to amend the FY 2019-20 CIP Budget by appropriating \$41,000 of Series “BI” (“AW”) Bonds and re-appropriating \$259,468 of Prop A Funds from “Major Street Rehabilitation – Citywide (FY 13-14 to FY 15-16),” Project No. 428-2590-XXXXX-68548 to “Pomona Transit Bridge Improvements and Beautification,” Project No. 428-2590-XXXXX-67927;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. The City Council amends the FY 2019-20 CIP Budget by unappropriating \$259,468 of Prop A funds from “Major Street Rehabilitation – Citywide (FY 13-14 to FY 15-16),” Project No. 428-2590-XXXXX-68548 and amends the FY 2019-20 CIP Budget by appropriating a combined \$300,468 of the available funds as follows:
