

RESOLUTION NO. 2019-133

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
POMONA, SITTING AS THE GOVERNING BOARD OF THE
POMONA HOUSING AUTHORITY, AMENDING THE POMONA
HOUSING CHOICE VOUCHER PROGRAM ADMINISTRATIVE
PLAN**

WHEREAS, in accordance with 24 CFR 982.54, the U.S. Department of Housing and Urban Development (HUD) requires each Housing Authority (HA) overseeing the Housing Choice Voucher Program to periodically update and adopt a written Administrative Plan;

WHEREAS, the Pomona Housing Authority Administrative Plan establishes local policies for administration of the Housing Choice Voucher Program in accordance with HUD requirements;

WHEREAS, HUD has developed a new approach to monitoring and policy development that requires all Housing Authorities to review and revise their Administrative Plans; and

WHEREAS, the Pomona Housing Authority, pursuant to Federal regulations, has prepared and submitted for approval to the Pomona Housing Authority Board the revised Administrative Plan.

NOW, THEREFORE, BE IT RESOLVED by the City Council, sitting as the Governing Board of the Pomona Housing Authority, as follows:

SECTION 1. That the Governing Board of the Pomona Housing Authority has reviewed on September 9, 2019 the revised Pomona Housing Authority Administrative Plan.

SECTION 2. That the Governing Board hereby authorizes submission of the revised Pomona Housing Authority Administrative Plan to the U.S. Department of Housing and Urban Development as mandated, which is on file in the office of the City Clerk and is incorporated herein by reference.

SECTION 3. That the Pomona Housing Authority Secretary shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its approval.
