

RESOLUTION NO. 2019-132

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, TO ACCEPT AND RECEIVE \$140,000 OF ADDITIONAL GRANT FUNDS FROM SAN GABRIEL AND LOWER LOS ANGELES RIVERS AND MOUNTAINS CONSERVANCY (RMC) AND AMEND “PHIL AND NELL SOTO PARK,” CIP PROJECT NO. 428-2590-XXXXX-71040 IN THE FY 2019-20 CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET BY RECEIVING AND APPROPRIATING \$140,000 OF SAN GABRIEL AND LOWER LOS ANGELES RIVERS AND MOUNTAINS CONSERVANCY GRANT FUNDS TO THE PROJECT

WHEREAS, the 2019-20 Capital Improvement Program (CIP) Budget for “Phil and Nell Soto Park,” Project No. 428-71040, is currently funded in the total amount of \$2,546,991 with California Natural Resources Agency Urban Greening Grant, San Gabriel and Lower Los Angeles Rivers and Mountains Conservancy (RMC) Grant, and Park and Recreation Improvement Fees;

WHEREAS, the City Council desires to accept and receive an additional \$140,000 in grant funding awarded from the RMC Grant;

WHEREAS, the City Council desires to amend the 2019-20 CIP Budget by appropriating an additional \$140,000 of the RMC Grant to “Phil and Nell Soto Park,” Project No. 428-71040; and

WHEREAS, it was determined that unforeseen additional construction costs were needed to complete the “Phil and Nell Soto Park,” Project No. 428-71040.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. The City Council accepts and receives an additional \$140,000 of RMC Grant Funds.

SECTION 2. The City Council amends the FY 2019-20 CIP Budget by appropriating an additional \$140,000 of the RMC Grant Funds to “Phil and Nell Soto Park,” Project No. 428-71040 as follows:
