

**RESOLUTION NO. 2019-134**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FISCAL YEAR 2019-20 ADOPTED OPERATING BUDGET BY APPROPRIATING \$10,948 FROM GENERAL FUND RESERVES, UTILIZING PREVIOUSLY DONATED FUNDS FROM THE FAIRPLEX, TO PROVIDE VEGETATION AND BRUSH CLEARANCE IN GANESHA PARK AND THE SURROUNDING HILLSIDES**

**WHEREAS**, the City Council wishes to provide Pomona residents with safe streets and neighborhoods; and,

**WHEREAS**, The Fairplex, as a partner in that endeavor, in FY 2014-15 donated \$50,000 to the City of Pomona to be used for improvements of the public park, open space, and rights-of-way in the Ganesha Park area; and,

**WHEREAS**, the City has completed various improvements in the Ganesha Park area utilizing this funding, leaving a remaining balance of \$10,948 for additional improvements; and,

**WHEREAS**, all appropriations lapse at the close of a fiscal year and an amendment to the approved FY 2019-20 Operating Budget is required to appropriate \$10,948 from the Fairplex donation to the General Fund to provide for vegetation clearance and associated equipment costs in Ganesha Park and the surrounding hillsides for wildfire prevention purposes.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**SECTION 1.** The City Council hereby amends the adopted FY 2019-20 Operating Budget by appropriating \$10,948 from General Fund Reserves for Ganesha Park area improvements to the Parks and Landscape Maintenance Operating Budget (101-4011-52920-00000).

**SECTION 2.** The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
