Dear Pomona City Council,

This October House of Ruth will be hosting our 14th Annual Candle Light Vigil in partnership with Foothill Family Services. October is Domestic Violence Awareness Month and the vigil is a time for the community of Pomona to come together and mourn the lives lost to domestic violence and celebrate the survivors who are with us today. This event is open to the community and provides a space of connectedness and healing for the families we serve, our staff, volunteers, community partners, and anyone who is impacted by domestic violence. Several local political officials have attended and spoken at the ceremony over the years, including Mayor Sandoval who has shared about the impact of domestic violence in his family growing up.

Many survivors of domestic violence suffer alone due to the isolation that often occurs in abusive relationships. Although House of Ruth works everyday to spread awareness and education around domestic violence, it is still viewed primarily as a family problem rather than a public one. The Candle Light Vigil is a vital part of the work we do to bring domestic violence out of the shadows and into the public eye, empowering all members of the community to educate themselves and keep our families safe.

Temporary assistance of a podium, sound equipment, and 100 folding chairs from the Pomona City Council will be used for House of Ruth's Annual Candle Light Vigil in October at our outreach center. This event has been consistently attended by 100-150 community members since it began in 2005.
