After a cost of service study and extensive financial analysis of the City's water, sewer, and recycled water utility funds, staff is recommending a new rate schedule, which increases the cost for temporary construction water over a five-year period. The proposed rate changes mirror that of other water users and, if approved will allow for full cost recovery.

# Recycled Water Used or Sold for Use Outside of the Area Served by the City

City customers who utilize, or resell, recycled water outside the area served by the City shall be charged the standard rate all utility water customers pay as long as there is sufficient recycled water to meet all customer demands. However, when the City is unable to meet all recycled water demands and must add potable water to the recycled water system, the amount charged for use outside of the area served by the City shall be the Tier 3 potable rate stated above.

Individuals with a disability requiring a modification or accommodation, including auxiliary aids or services, or require the services of an interpreter in order to participate in the public meeting may make these requests to the City Clerk's Office at (909) 620-2341. The City Clerk's Office will make every effort to accommodate requests for assistance. Requests should be made as soon as possible, and at a minimum of 24 hours in advance of the public hearing.

The cost recovery calculations for the proposed fees are contained within the fee analysis, which is available for review in the City Clerk's Office located at 505 South Garey Avenue, Pomona, California.
