Kathy Shin from Best Best & Krieger presented the proposed ordinance and answered questions from the Council.

Alan Contreras was in support of the ordinance and believes issues with it can be resolved

German Garcia was in support and said he was willing to follow all necessary procedures to be a legal sidewalk vendor.

Benjamin Wood was in support and expressed concerns with the ordinance as written.

Luis Suarez was in support and expressed concerns with the cost of the permits.

Larry Egan was in support of sidewalk vendors but with restrictions on the downtown area due to safety concerns.

John Pena was in support of immigrant businesses but the ordinance needs to benefit not just sidewalk vendors but brick and mortar businesses to be fair to everyone. He also expressed concerns about the health regulations.

Jim Sanbrano was in support of the idea of the ordinance but stated the ordinance as written is too restrictive, does not support entrepreneurship, and the costs are prohibitive to low income residents.

Elinor Crescenzi was also in support of the idea of the ordinance but stated there is too much restrictive language and needs to be written in a way that helps the people it is intended to benefit.

Ed Tessier was in support of the ordinance with location restrictions. He also stated that health and safety regulations were very important.

John Mendoza was in support of the ordinance but said the costs are too high and will prevent low income Pomona residents from being able to get the necessary permits.
