## **RESOLUTION NO. 2019-154**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING APPENDIX A OF THE COMPENSATION PLAN FOR EXECUTIVE MANAGEMENT GROUP A AND B EMPLOYEES BY INCREASING THE SALARY SCALE FOR COMMUNITY SERVICES MANAGER

**WHEREAS**, the City Council has the authority to create, classify and assign salary scales/ranges to the Compensation Plan for Executive Management Group A and B Employees (A-B Plan) of the City of Pomona;

WHEREAS, the City Council has the authority to amend the staffing allocations;

**WHEREAS,** on September 17, 2018, the City Council adopted Resolution No. 2018-136 amending the A-B Rules;

**WHEREAS,** the City Council adopted the operating budget of the City of Pomona for Fiscal Year 2019-2020 on June 3, 2019, which included the authorized Citywide staffing allocations; and

**WHEREAS**, the City Council desires to amend Appendix A of the aforementioned A-B Rules by adding a classification by the action herein.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Pomona as follows:

**SECTION 1**. That the City Council hereby authorizes changes to be made to Appendix A of the A-B Plan by increasing the salary scale of Community Services Manager as shown below based upon salaries in effect on July 1, 2019:
