A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FY 2018-2019 CITY'S OPERATING BUDGET BY APPROPRIATING \$72,000 TO PAY AN OUTSTANDING JUNE 2019 INVOICE FOR THE POMONA OPERATION PORCHLIGHT GRANT PROGRAM

WHEREAS, on May 20, 2009 Congress enacted the HEARTH Act into law, consolidated homeless assistance programs administered by the U.S. Department of Housing and Urban Development (HUD) under the McKinney-Vento Homeless Assistance Act into a single grant program called the Continuum of Care (CoC) program;

WHEREAS, the City of Pomona has been designated by the Los Angeles Homeless Services Authority (LAHSA), acting as the CoC lead agency for L.A. County, eligible to submit applications to HUD for CoC program grant funds;

WHEREAS, the City has been awarded CoC program renewal grant funding in the amount of \$604,936 from LAHSA to operate a Rapid Re-Housing program for the current grant year term of January 1, 2019 to December 31, 2019;

WHEREAS, the City has awarded a one-year contract to Volunteers of America Los Angeles (VOALA) in the amount of \$558,628 to administer the Pomona Operation Porchlight Rapid Rehousing program for the current grant year term of January 1, 2019 to December 31, 2019;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. Amend the FY 2018-2019 Operation Porchlight Fund (136-XXXX-XXXX-58702) by appropriating \$72,000 from fund balance to pay outstanding June invoice from VOALA for the Pomona Operation Porchlight Rapid Rehousing Program.

SECTION 2. The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its approval.
