

RESOLUTION NO. 2019-174

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, ACCEPTING \$4,000,000 IN LEAD HAZARD REDUCTION GRANT FUNDS AND \$600,000 IN HEALTHY HOMES SUPPLEMENT; AMENDING THE FY 2019-2020 OPERATING BUDGET TO INCREASE REVENUE ESTIMATES AND APPROPRIATE \$4,000,000 IN FEDERAL FUNDS FOR THE LEAD HAZARD CONTROL PROGRAM AND \$600,000 FOR THE HEALTHY HOMES PROGRAM

WHEREAS, on August 1, 2019, the Neighborhood Services Department applied for the Lead Hazard Reduction Grant Program and Healthy Homes Supplement through the U.S. Department of Housing and Urban Development;

WHEREAS, on September 30, 2019, notification was received that the City of Pomona was awarded a grant in the amount of \$4,000,000 from the Lead Hazard Reduction Grant Program and \$600,000 from the Healthy Homes Supplement;

WHEREAS, the Neighborhood Services Department desires to accept the Lead Hazard Reduction Grant Funds and Healthy Homes Supplement and to amend the Fiscal Year 2019-2020 City Operating Budget to increase revenue estimates and appropriate \$4,000,000 in Federal funds for the Lead Hazard Control Program and \$600,000 for the Healthy Homes Program;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. The City Council accepts \$4,000,000 in Lead Hazard Reduction Grant Funds and \$600,000 in Healthy Homes Supplement, and amends the Fiscal Year 2019-2020 Operating Budget to increase revenue estimates and appropriate \$4,000,000 in Federal Funds for the Lead Hazard Control Program and \$600,000 for the Healthy Homes Program.

SECTION 3. The City Clerk shall attest and certify to the passage of this Resolution and it shall thereupon take effect and be in full force.
