#### PLEDGE OF ALLEGIANCE

Member of the American G.I. Forum of California, Howard Hernandez, led the Pledge of Allegiance.

#### MAYOR/COUNCILMEMBER COMMUNICATIONS

In accordance with AB1234, the Mayor and Councilmembers reported on the following:

Councilmember Ontiveros-Cole spoke on the success of the Santa Cop Toy Drive and toy drive event at Victory Outreach.

Councilmember Gonzalez spoke on the Council's attendance to the following various City events: Padua Hills Theatre event, Millard Sheets Panels event, Holiday at the Plaza Christmas Parade, Metro Gold Line Meeting, Cesar Chavez Park community event, Grand Opening of "La Cachanilla Market," Showing of the film "Don't Worry He Won't Get Far on Foot" presented by the Pomona Valley Film Society.

Councilmember Garcia thanked the Pomona American Little League for their donation of toys to District 3.

Councilmember Lustro spoke on his participation in the Pomona Christmas Parade and also shared that he had attended the Pomona Police Department's Volunteer Luncheon. He also shared that he had attended the Santa Cop Toy Drive event.

Councilmember Torres thanked Mayor Sandoval for the invitation to join his clean-up crew where he assisted in cleaning up various locations within the City. He also expressed his enjoyment in being part of the Pomona Christmas Parade. He also shared that he would be hosting his 2<sup>nd</sup> Annual Toy Drive.

Mayor Sandoval thanked the community for all the various events occurring within the City. He also acknowledged Councilmember Garcia and Councilmember Lustro for their service as city commissioners.

Councilmember Preciado recognized the various community members who help in make a difference in the City.

Councilmember Ontiveros-Cole spoke on the new homeless shelter built in the City and her attendance at the HEROS Award event.

#### CITY MANAGER COMMUNICATIONS

City Manager Linda Lowry commended the City Councilmembers in their volunteering efforts of serving meals at the Hope for Home homeless shelter.

#### PUBLIC PARTICIPATION

Douglas Pierce spoke on the migration of people to the United States.

Howard Hernandez spoke on concerns he had with respect to medical care and other services for veterans within the community.

Brenda Morris spoke on her concerns regarding the Fairplex RV Park and asked Council to review the affordable rental covenant and also asked for Council's overall support and assistance.

Brian Schindler asked the Council to review the rental covenant for the Fairplex RV Park because he indicated that the Fairplex was not in compliance with the rental covenant.

Irene Hansen spoke on her concern with invoices received of fines sent by the Pomona Police Department for false alarms.

Orlando Arias asked the City Council to add more left hand turn signals at Orange Grove at Dudley, White and Hamilton.

Bob Cruz, Public Affairs Manager for Southern California Gas Co., spoke on the issue of the State of California wanting to electrify all buildings, including homes, and the cost in retrofitting buildings to become all electrical based.

Kyle Brown, member of Clean and Green Pomona, spoke on the truck routes located within the City and asked City staff for an update and asked the City Council to place this item on the next agenda.

Damiana Aldana, member of Clean and Green Pomona, also requested that the City Council add the item of truck routes to the City Council's next agenda.

Daniel Valles shared with the Council that he would like to open a cannabis business within the City of Pomona.

Tammy Roush gave an update on events occurring at the Fairplex and events that the Fairplex is associated with.

Randy Bekenham spoke on his concern regarding homelessness and hunger and what can be done to assist with these social issues and encouraged the Council to think creatively with respect to these issues.

Michael Webb congratulated the City Council on taking on the challenges within the City. Mr. Webb also spoke about an individual in the City who is running his own private tow company and charging residents for this service along with storage fees. He asked the City Council to look into this private tow company and their business license.

A motion was made by Councilmember Torres and seconded by Councilmember Ontiveros-Cole, to adopt Resolution No. 2018-178 & Resolution No. 2018-179. Motion carried by a vote of 7-0.

Mayor Sandoval asked if there were any Councilmembers who wished to add to the Finding of Public Benefit list items that came up after the posting of the agenda.

Councilmember Garcia indicated that she would like to assist the Ranch Rescue Team with \$250 to chip, vaccinate and spay & neuter pets at Hope for Home.

Mayor Sandoval asked that this new Finding of Public Benefit item requested by Councilmember Garcia be added to the January 7, 2019 agenda.

A motion was made by Councilmember Torres and seconded by Councilmember Garcia, to approve the items on the Finding of Public Benefit list. Motion carried by a vote of 7-0.

22. Certification of Citizen Sponsored Initiative Measure (The "Initiative") to Enact a Three Quarter Percent (0.75%) Increase in the City's Utility Users Tax; Receive and File the Impact Analysis of the Initiative Prepared Pursuant to Section 9212 of the California Elections Code; and Consider Whether to Adopt the Proposed Ordinance or Direct Staff to Prepare said Ordinance/Initiative for Placement on the Ballot of the Next General Election

Speaker John Mendoza spoke on rebates to disabled/handicapped residents of Pomona with regard to this tax and asked about oversight with regard to the City Attorney.

Finance Director Jones gave an overview of Item No. 22.

Councilmember Torres inquired about the petition received and its qualification on the ballot for the November 2020 election.

Finance Director Jones indicated that enough sufficient signatures were received in order for the petition to qualify to be placed on the November 2020 election ballot.

Interim City Attorney Hogin added that due to this initiative being a tax measure, under Proposition 13, it was required to be placed on the ballot for voter approval.

Councilmember Torres asked if this tax measure needed a 50% or 2/3 voter approval vote.

Interim City Attorney Hogin stated that since proceeds of the proposed tax were to go into the General Fund, it would need a 50%+1 voter approval vote. If proceeds were designated for a specific purpose, the proposed tax would need a 2/3 vote.

Councilmember Ontiveros-Cole asked for clarification on who would benefit from this citizen sponsored initiative. She also asked about exemptions for senior citizens and low-income residents.

Finance Director Jones explained that this proposed initiative would be an exemption for handicap residents with Pomona since the original petition received signatures specifically for handicap residents.

Councilmember Garcia stated that low-income residents who might be disabled and/or handicapped may already be under an exemption.

Councilmember Lustro commented on the approach that was taken in bringing forward this citizen sponsored initiative.

Councilmember Torres commended John Mendoza on securing the large number of signatures that were needed to place the citizen sponsored initiative.

Mayor Sandoval asked about an impact report for the proposed initiative.

City Manager Lowry indicated that an impact analysis was available in the agenda packet for Council review.

A motion was made by Mayor Sandoval and seconded by Councilmember Lustro, to direct staff to place initiative on the ballot of the next General Election in November 2020. Motion carried by a vote of 7-0.

Mayor Sandoval requested that Item No. 24 be heard before Item No. 23. A motion was made by Mayor Sandoval and seconded by Councilmember Garcia to move Item No. 24 before Item No. 23.

**24.** Discussion Regarding Possible Use of City Owned Property Located on South Buena Vista Avenue (APN 8349-026-902) for Urban Gardening

Mayor Sandoval proceeded to Council discussion on Item No. 24.

Councilmember Preciado stated his support of Item No. 24.

Councilmember Garcia asked about irrigation being available on the property where proposed community garden was to be placed and who would be responsible for connection fees for irrigation to be connected to the main water line.

Deputy City Manager Kirk Pelser indicated that further investigation would need to be done to determine if irrigation was available on the property. He also indicated that if a water meter was present at the property, the irrigation fees would be the responsibility of the user.

Mayor Sandoval thanked all those who came to speak in support of Item No. 24 and also spoke of his support of the item and the possible future purchase of property by user. Mayor Sandoval asked the proposed user for yearly reports to Council on the progress of the community farm.

Deputy City Manager Pelser shared that a license use agreement could be brought forth for Council review and approval at the beginning of the New Year which would be a policy guideline for the land use of the property by the user.

Councilmember Gonzalez commended United Voices on securing a \$50,000 grant for the proposed community garden and also said he echoed the Mayor's ideas for the license use agreement. He also said he would like to see this project become a pilot program for other future community projects.

Councilmember Ontiveros-Cole thanked all those from United Voices who came out to speak in support of item and stated that this project would become an asset to the community.

Councilmember Torres thanked the speakers who came out in support of Item No. 24 and indicated that this project has the potential to gain the support from other organizations and affluent individuals. He also stated that he would be in support of the license use agreement.

Councilmember Lustro thanked all individuals who came out to speak in support of the community garden and their passion for the project and supported the projected.

Councilmember Garcia inquired about the amount that would be needed for liability insurance for the project and also would like to see a neighbor response system for neighbor complaints.

A motion was made by Councilmember Garcia and seconded by Councilmember Preciado, to direct staff to work with applicant to return to Council at the second meeting in January 2019 the documents needed to create a community urban garden on the proposed location for a nominal fee along with appropriate conditions and liability insurance. Motion carried by a vote of 7-0.

Councilmember Preciado asked to confirm on the voting of Vehicle Parking District (VPD) commissioner appointments at the first meeting of January 2019.

City Manager Lowry indicated that the VPD commissioner appointments would be an item on the first agenda of January 2019.

Councilmember Gonzalez inquired on the possibility of getting the roof of the library fixed in order to avoid further damage.

City Manager Lowry stated that the historical buildings took precedence over municipal buildings and that a report would be given to Council on a weekly on the urgency and priority of which city building needed to have its roof fixed first.

Councilmember Ontiveros-Cole also inquired on the library roof being fixed and informed Councilmember Gonzalez about a complaint made from a resident in his district regarding loud music. She also inquired about lights not being lit.

Mayor Sandoval stated that one of the challenges for government entities is to find able individuals to carry out large projects such as homeless centers and roads. He asked if it was possible to work with other cities in the region to make these type of large projects possible that would benefit not only the City of Pomona but surrounding cities as well.
