#### MAYOR/COUNCILMEMBER COMMUNICATIONS

The Council encouraged residents to attend Indigenous People Event at Ganesha Park on October 12, the Second Saturday Art Walk, Pomona 5K/10K, and various upcoming community meetings.

City Manager Linda Lowry reported the Pomona Transit Bridge project was on track however, the Union Pacific Big Boy train would not be able to stop in Pomona due to schedule conflicts.

James Curtis spoke on NAMI-National Alliance for Mental Illness and the Pomona chapter.

Endy Farrow and Mattie Johnson spoke on the P.E.A.R.L.S. program (Providing Empowerment & Acceptance through Resources & Love for Single Parents) and what work they do in the Pomona community.

John Clifford spoke on an upcoming library event where the time capsule from 1969 will be discussed. He also reported that the deadline for the poet laureate program will be October 31.

Deborah Clifford spoke on historical events coming up: Halloween tour at Spadra cemetery on October 31, Mourning Tour at Phillips Mansion on October 20, Ebell Mansion event October 19.

Martha Hernandez, Luis Castro, and Andrew Miron from the Pomona Student Union all spoke on the need to reinstate the Youth Commission.

Ben Wood spoke about a Pomona Economic Opportunity Center fundraiser where the Sanctuary Movement by P.U.S.H. was recognized.

Valeria Gamboa did not wish to speak but supported Tony Cerda Park improvements.

Reina Buelna and Deanna Hernandez both spoke on concerns for Tony Cerda Park conditions.

Mark Gluba, Deputy City Manager, gave the presentation.

Isis Pulido spoke on her concern that this ordinance will hurt her taco truck business.

Ben Wood spoke on the need to include the legislative intent in the ordinance. He also expressed concern for the education process for vendors and had a concern for the insurance requirement.

Cathy Tessier spoke on the concern for safety and security in the downtown area if vendors are allowed. She stated tenants have been lost due to vendors in the downtown area.

Gluba clarified for councilmembers that this ordinance was strictly for sidewalk vendors on the City right-of-way and did not apply to food trucks or food vendors on private property.

Councilmembers discussed distances allowed from driveway entrances. Councilmember Preciado asked what the enforcement plan would be. Councilmember Garcia asked for a report in 6-12 months to see how this ordinance is working. Mayor Sandoval inquired about helping entrepreneurship through Finding of Public Benefit.

14. Approval of a Purchase and Sale Agreement Between The City of Pomona and Seventh Street Development, Inc. for the Conveyance of Certain Real Property Commonly Known as Veteran's Park (Assessor Parcel No's. 8707-019-903, 906 & 909), pursuant to Government Code Section 37420 et seq

It is recommended that the City Council adopt the following resolution:

#### RESOLUTION NO. 2019-158

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, APPROVING A PURCHASE AND SALE AGREEMENT BETWEEN THE CITY OF POMONA AND SEVENTH STREET DEVELOPMENT, INC. FOR CONVEYANCE OF CERTAIN REAL PROPERTY COMMONLY KNOWN AS VETERAN'S PARK (ASSESSORS PARCEL NO. 8707-019-903, 906, & 909) TO SEVENTH STREET DEVELOPMENT, INC. PURSUANT TO GOVERNMENT CODE SECTION 37420 ET SEQ

Kirk Pelser, Deputy City Manager, and Mike Osoff, Community Services Director, gave the presentation about the condition of Veterans Park and other City park improvements that could be funded from the net sale of the park.

# MOTION BY COUNCILMEMBER TORRES, SECOND BY COUNCILMEMBER GARCIA, CARRIED 6-0 (COUNCILMEMBER ONTIVEROS-COLE ABSENT), to open the Public Hearing.

Don Martens from Clean and Green Pomona opposed the sale as it is currently written and said the money from the sale should be used to buy more park space.

Damiana Aldana from Clean and Green Pomona was opposed to losing park space and Pomona needs to add more parks.

Edward Samaniego spoke on the need for more significant upgrades at Tony Cerda Park then was indicated in the presentation. He said the legacy of Tony Cerda needed to be protected.

Daniel Enz from Norma Torres' office did not wish to speak but supported the sale of Veterans Park.

# MOTION BY COUNCILMEMBER PRECIADO, SECOND BY COUNCILMEMBER GARCIA, CARRIED 6-0 (COUNCILMEMBER ONTIVEROS-COLE ABSENT), to close the Public Hearing.

Discussion took place among Councilmembers about what the net sale proceeds could be used for in addition to what was mentioned in the presentation. The City Attorney advised councilmembers that their discussion was becoming too specific and could be a violation of the Brown Act.

MOTION BY COUNCILMEMBER PRECIADO, SECOND BY COUNCILMEMBER GARCIA, CARRIED 5-1 (COUNCILMEMBER TORRES OPPOSED, COUNCILMEMBER ONTIVEROS-COLE ABSENT), to adopt Resolution No. 2019-158 with added language that would set aside the net sale proceeds into a special revenue fund for park improvements only.

#### MATTERS INITIATED BY CITY COUNCILMEMBERS

Councilmember Torres had questions about a vacant lot on Garey and Arrow and an illegal marijuana dispensary and the property next to the Dollar Tree on LaVerne.

Councilmember Garcia thanked parks staff involved with the field trip to the Museum of Tolerance. She spoke on an upcoming clean up and mural painting at Philadelphia Park.

Councilmember Preciado asked for information about the process of applying for business licenses.

Mayor Sandoval spoke on the HDTV show Extreme Makeover filming in Pomona. He also thanked those that attended the Metro Gold Line Press Conference. He thanked staff for the summer concert series.
