- A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AUTHORIZING THE SUBMITALL OF AN APPLICATION TO THE FIRE PREVENTION GRANT PROGRAM OF THE CALIFORNIA DEPARTMENT OF FORESTRY AND FIRE PROTECTION (CAL FIRE)
- **WHEREAS**, the Governor of the State of California, in cooperation with the California State Legislature, has enacted State of California Greenhouse Gas Reduction Funding, which provides funds to the State of California and its political subdivisions for forest health programs; and
- **WHEREAS**, the State Department of Forestry and Fire Protection has been delegated the responsibility for administration of the program within the State, setting up necessary procedures governing application by local agencies, non-profit organizations, and others under the program; and
- **WHEREAS**, said procedures established by the State Department of Forestry and Fire Protection require the applicant to certify by resolution the approval of application before submission of said application to the State; and
- **WHEREAS**, the applicant will enter into an agreement with the State of California to carry out a forest health project;
- **NOW, THEREFORE, BE IT RESOLVED** that by the City Council of the City of Pomona, California hereby:
- **SECTION 1.** Approves the filing of an application for "State Greenhouse Gas Reduction Funding" forest health grant program funds; and
- **SECTION 2.** Certifies that said applicant has or will have sufficient funds to operate and maintain the project; and
- **SECTION 3.** Certifies that funds under the jurisdiction of the City of Pomona are available to begin the project; and
- **SECTION 4.** Certifies that said applicant will expend grant funds prior to March 30, 2022.
- **SECTION 5.** Appoints the City Manager, or a designee, as agent of the City Council to conduct all negotiations, execute and submit all documents including, but not limited to applications, agreements, amendments, payment requests, and so on, which may be necessary for the completion of the aforementioned project.
