

RESOLUTION NO. 2019-187

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AUTHORIZING THE ACCEPTANCE OF \$353,230 IN COUNTY OF LOS ANGELES MEASURE H SPECIAL FUNDS AND \$254,270 IN STATE HOMELESS EMERGENCY AID PROGRAM (HEAP) FUNDS FOR OPERATION OF A BRIDGE HOUSING PROGRAM AT THE HOPE FOR HOME SERVICES CENTER, AMENDING THE FY2019-20 OPERATING BUDGET BY INCREASING REVENUE ESTIMATES AND APPROPRIATING \$607,500 IN GRANT FUNDS, AND AMENDING THE AGREEMENT OF VOLUNTEERS OF AMERICA LOS ANGELES BY AWARDING \$558,601 TO OPERATE THE BRIDGE HOUSING PROGRAM AS THE HOPE FOR HOME SERVICES CENTER SITE OPERATOR

WHEREAS, the Los Angeles Homeless Services Authority (LAHSA) is authorized to enter into contracts to allocate funding for homeless programs and projects the County;

WHEREAS, the City of Pomona (City) responded to a Request for Proposals released by LAHSA to operate a Bridge Housing Program, funding 50 beds at the Hope for Home Services Center.

WHEREAS, on October 25, 2019 LAHSA's Board of Commissioners approved the award of funding to the City;

WHEREAS, funding for this Program is made available by LAHSA through Los Angeles County Measure H Funds in the amount of \$353,230 and State Homeless Emergency Aid Program (HEAP) Funds in the amount of \$254,270 for the term of November 1, 2019 to June 30, 2020;

WHEREAS, the City acknowledges that this is a pro-rated funding for FY 2019-2022 with a multiyear contract term subject to the availability of funds each fiscal year; and,

WHEREAS, the City has certified that Volunteers of America Los Angeles (VOALA) is a qualified and experienced housing and social service organization which enhances services to homeless populations, and as the Hope for Home Services Center Site Operator should receive \$558,601 of the funds awarded by LAHSA to operate the Bridge Housing Program at the Hope for Home Services Center.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. Authorizes the acceptance of \$353,230 in County of Los Angeles Measure H Special Funds and \$254,270 in State Homeless Emergency Aid Program (HEAP) Funds for Operation of a Bridge Housing Program at the Hope for Home Services Center.

SECTION 2. Amends the FY 2019-20 Operating Budget by increasing revenue estimates and appropriating \$310,843 in County Measure H funds to 139-1791-XXXXX-58709 for program operation and \$42,387 to 139-1702-XXXXX-58709 for administrative costs.

SECTION 3. Amends the FY 2019-20 Operating Budget by increasing revenue estimates and appropriating \$223,758 in State HEAP funds to 215-1791-XXXXX-58709 for program operations and \$30,512 to 215-1702-XXXXX-58709 for administrative costs.

SECTION 3. Authorizes an award of \$558,601, to include \$322,843 in Measure H funding and \$235,758 in HEAP funding to VOALA as the Hope for Home Services Center Site Operator, to be used for operational and administrative costs for the Bridge Housing Program per the Program Agreement with LAHSA.

SECTION 4. Authorizes the City Manager to execute all agreements and any other documentation requested for acceptance of the award, distribution of the funding and operation of the Hope for Home Bridge Housing Program, subject to approval as to form by the City Attorney.
