

RESOLUTION NO. 2019-183

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, AMENDING THE FY 2019-20 CAPITAL IMPROVEMENT PROGRAM BUDGET BY APPROPRIATING \$35,473 OF AVAILABLE WATER FUNDS RESERVES TO THE “STREET PRESERVATION – LOCAL CITYWIDE (FY 18-19),” PROJECT NO. 428-2590-XXXXX-68560.

WHEREAS, the City Council is prescribed the authority, by Charter of the City of Pomona, to adopt Capital Improvement Program (CIP) budgets;

WHEREAS, the project “Street Preservation – Local Citywide (FY 18-19)”, Project No. 428-2590-XXXXX-68560 is included in the adopted FY 2019-20 CIP budget;

WHEREAS, \$35,473 from Water Fund reserves is available to be appropriated for the “Street Preservation – Local Citywide (FY 18-19)”, Project No. 428-2590-XXXXX-68560;

WHEREAS, the proposed appropriation is necessary to provide funding for additional pavement costs in the amount of \$35,473; and

WHEREAS, the City Council desires to amend the FY 2019-20 CIP Budget by appropriating \$35,473 of Water Fund balance to the “Street Preservation – Local Citywide (FY 18-19)”, Project No. 428-2590-XXXXX-68560.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. That the City Council hereby amends the FY 2019-20 CIP budget by appropriating \$35,473 of Water Fund reserves to the “Street Preservation – Local Citywide (FY 18-19)”, Project No. 428-2590-XXXXX-68560, leaving the project fully funded.

SECTION 2. That the City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its approval.
