

**RESOLUTION NO. 2019-202**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA AMENDING THE CITYWIDE SALARY SCHEDULE FOR FISCAL YEAR 2019/2020 TO REFLECT CLASSIFICATION CHANGES TO APPROVED ON DECEMBER 16, 2019**

**WHEREAS**, the City Council has the authority to create, classify, and design salary scales/ranges for all City of Pomona employee positions;

**WHEREAS**, CCR 570.5 and 571 requires a consolidated Salary Schedule that is publically available showing all City classifications and salary ranges for purposes of determining eligible salary compensation for retirement;

**WHEREAS**, the City Council adopted the citywide Salary Schedule for Fiscal Year 2019/20 on July 15, 2019, which set forth the salary scales/ranges for all City of Pomona employee classifications;

**WHEREAS**, the City Council amended the citywide Salary Schedule for Fiscal Year 2019/20 on October 7, 2019; and

**WHEREAS**, the City Council wishes to further amend the citywide Salary Schedule to reflect changes approved by City Council on December 16, 2019.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Pomona as follows:

**SECTION 1.** That the City Council hereby amends the citywide Salary Schedule for Fiscal Year 2019/20, as set forth in the attached Exhibit A, to reflect classifications and salary changes approved by City Council on December 16, 2019, by Resolution Nos. 2019-198, 2019-199, 2019-200 and 2019-201.

**SECTION 2.** The new classifications and salary adjustments approved by City Council Resolution Nos. 2019-198, 2019-199, 2019-200 and 2019-201 become effective January 5, 2020.

**SECTION 3.** The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its adoption.
