

RESOLUTION NO. 2020-04**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA AMENDING THE FY 2019-20 OPERATING BUDGET BY APPROPRIATING \$307,000 OF LOS ANGELES COUNTY REGIONAL PARK AND OPEN SPACE DISTRICT GRANT FUNDS TO TREE PLANTING PROJECTS IN THE NORTHSIDE AND SOUTHSIDE STUDY AREAS**

WHEREAS, in August 2016, the City submitted two grant applications to the Los Angeles County Regional Park and Open Space District (LACRPOSD) for the FY 2016-17 Competitive Excess Tree Planting Grant Program, one for the Northside Study Area (Council Districts 1, 4, and 6) and one for the Southside Study Area (Council Districts 2, 3, and 5); and

WHEREAS, on January 31, 2017, the City was notified that it was awarded a \$200,000 grant for the “Northside Study Area Tree Planting Project” to be fully expended by the grant term expiration of December 31, 2021; and

WHEREAS, on January 31, 2017, the City was notified that it was awarded a \$200,000 grant for the “Southside Study Area Tree Planting Project” to be fully expended by the grant term expiration of December 31, 2021; and

WHEREAS, on May 1, 2017, the City Council adopted a Resolution accepting and receiving the LACRPOSD grant funds and authorized the City Manager to execute all agreements and documents related to the Tree Planting Grant Programs, including agreements with the California Conservation Corps – Pomona Center and the San Gabriel Valley Conservation Corps.

WHEREAS, the City will begin the Northside Area and Southside Area Tree Planting Projects in early 2020.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. Authorizes the amendment of the FY 2019-20 Operating Budget by appropriating \$153,500 in LACRPOSD funding to the “Northside Study Area Tree Planting Project” Fund 215-2506-XXXXX-58672; and

SECTION 2. Authorizes the amendment of the FY 2019-20 Operating Budget by appropriating \$153,500 in LACRPOSD funding to the “Southside Study Area Tree Planting Project” Fund 215-2506-XXXXX-58673; and
