

RESOLUTION NO. 2020-01

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, ACCEPTING \$5,130 IN BOARD OF STATE AND COMMUNITY CORRECTIONS (BSCC) MENTAL HEALTH TRAINING GRANT FUNDS, AND AMENDING THE FY 2019-20 OPERATING BUDGET BY INCREASING REVENUE ESTIMATES AND APPROPRIATING \$5,130 IN BSCC GRANT FUNDS

WHEREAS, the Police Department has been awarded a Mental Health Training Grant by the Board of State and Community Corrections (BSCC) for a total award of \$5,130;

WHEREAS, the Mental Health Training Grant is designed to provide funds to attend statewide mental training initiatives to provide critical training to corrections personnel;

WHEREAS, these training courses include content such as signs and symptoms of mental illness, substance abuse disorder, trauma informed care, crisis intervention and suicide prevention.

WHEREAS, the authority to accept the Board of State Community Corrections (BSCC) Mental Health Training Grant made available by the Edward Byrne Memorial Justice Assistance Grant (JAG) Program and amend the current operating and revenue budgets to appropriate grant funds to be received is vested with the City Council,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. That the City Council hereby accepts the Board of State Community Corrections (BSCC) Mental Health Training Grant made available by the Edward Byrne Memorial Justice Assistance Grant (JAG) Program and agrees to the terms and conditions of the Grant Agreement.

SECTION 2. That the City Council hereby amends the FY 2019-20 Operating Budget by Increasing Revenue Estimates and Appropriations (239-2090-XXXXX-58711) in the amount of \$5,130 in the Board of State Community Corrections (BSCC) Mental Health Training Grant Funds.

SECTION 3. That the City Manager, or designee, is hereby authorized to execute any and all agreements on behalf of the City, in substantially the form submitted, subject to review and approval by the City Attorney.

SECTION 4. That City Clerk shall attest to and certify to the passage and adoption of this resolution and it shall be effective immediately upon its approval.
