Main Street, Bozeman, MT 59715. Councilmembers Gonzalez and Torres arrived to the meeting at 5:40 p.m. City Attorney Carvalho reported that Council discussed Item's A & B but no reportable action was taken. She also reported that a brief update was given to Council on Item C.

MAYOR/COUNCILMEMBER COMMUNICATIONS

Councilmember Gonzalez reported that the City of Pomona participated in the TV show "Extreme Make Over – Home Edition." He also spoke on his attendance to the Vietnamese Children's Festival and to the National Association of Latino Elected Officials (NALEO) Emergency Response Seminar held in Long Beach.

Councilmember Lustro shared that he had attended the celebration of life of former Pomona Mayor Chuck Bader at the Sheraton Fairplex.

Councilmember Ontiveros-Cole spoke on her attendance to the Vietnamese Children's Festival and also shared that a new food bank would be opening at 288 E. Holt Avenue which will be operated by business owner Alan Espinoza and also new business of the Family Dollar Store next door would be opening soon. Councilmember Ontiveros-Cole also expressed that a new restaurant would also be opening soon within the City. She also announced that on September 30th the Police Department would be hosting a Crime Prevention Workshop for City business owners.

Councilmember Torres spoke on the positive impact that the newly installed speed radar detectors on White and Fairplex Drive have had in controlling speed limits and added that he would like to implement these detectors in other areas of his district. Councilmember Torres also shared that California legislators recently passed a rent control law and also spoke on the banning of e-cigarettes in New York and urged the public not smoke e-

cigarettes because of all the health issues they promote. He also spoke on the issue of cannabis zones within the City of Pomona residents and business owners to continue to voice their opinions and add their feedback regarding this issue.

Councilmember Garcia shared that she also attended the memorial service for former Pomona Mayor Chuck Bader and extended condolences to the family on behalf of the City. She also reminded the public that the last summer concert would be taking place at Civic Center Plaza at 7:00 p.m. on September 21, 2019. Councilmember Garcia also shared that the community survey for the City Manager position was now available for the public to complete and that the next District 3 Community Meeting would be held at Renacimiento Community Center on October 9, 2019 at 6:30 p.m.

Vice-Mayor Preciado invited the public to the District 2 Community Meeting at the Lexington Cafeteria at 6:00 p.m. on September 17, 2019. He also thanked the dA Center for the Arts and Mike Suarez for their work on the car show and also for their input on the next mural to be located on Second and Main. Vice-Mayor Preciado also thanked the Hispanic Chamber of Commerce for their Latin American Independence Day events.

Councilmember Ontiveros-Cole added that the Mount View Community Meeting would be taking place on September 18, 2019 at 6:30 p.m.

Ann Tomkins shared her concern on the lack of grant funding for more shelter beds and also her concerns on neighboring cities sending their homeless over to the City of Pomona.

Jed Leano, City of Claremont Councilmember, thanked the City of Pomona and City of La Verne on this Tri-Cities Cohort project and Measure H funding.

Benita DeFrank, Neighborhood Services Director, explained how the funding of this particular grant would be distributed to assist with the issue of homelessness within the City of Pomona and also neighboring cities of Claremont and La Verne.

Councilmember Gonzalez thanked all those involved with bringing these Measure H funds to the City.

Councilmember Torres thanked staff for the work being done on the issue of homelessness within the City of Pomona and neighboring cities.
