

RESOLUTION NO. 2020-02

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, APPROVING THE POLICE DEPARTMENT ENTERING INTO AN AGREEMENT WITH THE CITY OF LA VERNE FOR BOOKING AND HOUSING ARRESTEES AT THE POMONA CITY JAIL AND AMENDING THE FY 2019-20 OPERATING BUDGET BY INCREASING REVENUE ESTIMATES AND APPROPRIATIONS BY \$191,022 AND INCREASE AUTHORIZED STAFFING TO INCLUDE TWO (2) NEW JAILER POSITIONS

WHEREAS, Pomona Police Department has qualified and certified Police Jailers to book and house arrestees in accordance with the State of California and local laws;

WHEREAS, the City of La Verne Police Department will transport to the Pomona City Jail those arrestees they desire to be booked in the Pomona City Jail;

WHEREAS, the City of Pomona agrees to accept and provide for the secure custody, care, and safekeeping of the La Verne Police Departments arrestees in accordance with federal, state and local laws.

WHEREAS, the City of La Verne Police Department will pay the total salary and benefits for two (2) Police Jailers;

WHEREAS, the two (2) Police Jailer positions will support and increase operations within the Pomona City Jail and help maintain services offered to the City of La Verne Police Department arrestees;

WHEREAS, the authority to amend the adopted budget and increase authorized staffing levels is vested with the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. That the City Council hereby accepts the Memorandum of Understanding (MOU) with the City of La Verne Police Department and agrees to the terms and conditions of the agreement.

SECTION 2. That the City Council hereby amends the FY 2019-20 Operating Budget by increasing revenue estimates (101-2031-40916-00000) and appropriations (101-2031-5-00000) by \$191,022.

SECTION 3. That the City Council authorizes the increase of Professional Civilian Staff to include two (2) new Police Jailer positions.

SECTION 4. That the City Manager is hereby authorized to execute any and all agreements on behalf of the City, in substantially the form submitted, subject to review and approval by the City Attorney.

SECTION 5. That City Clerk shall attest to and certify to the passage and adoption of this resolution and it shall be effective immediately upon its approval.
