WHEREAS, the City Council desires to amend the Fiscal Year 2019-20 Capital Improvement Program (CIP) Budget for "Street and Alley Rehabilitation Improvements – District 3," Project No. 428-2590-XXXXX-71051, by appropriating additional funds and amending the Project Description;

WHEREAS, the City Council desires to amend the Fiscal Year 2019-20 Capital Improvement Program (CIP) Budget for "Major Street Rehabilitation – Citywide (FY 13-14 to FY 15-16)," Project No. 428-2590-XXXXX-68548, by unappropriating \$80,000 of Measure R funds;

WHEREAS, the City Council desires to amend the Fiscal Year 2019-20 CIP Budget for "Street Improvements – District 5," Project No. 428-2590XXXXX-71045, by appropriating additional funds;

WHEREAS, the City Council desires to amend the Fiscal Year 2019-20 CIP Budget for "Street Rehabilitation – District 6," Project No. 428-2590-XXXXX-67921, by appropriating additional funds; and,

WHEREAS, the City Council desires to amend the "Street and Alley Rehabilitation Improvements – District 3," Project No. 428-2590-XXXXX-71051; "Street Improvements – District 5," Project No. 428-2590XXXXX-71045; "Street Rehabilitation – District 6," Project No. 428-2590-XXXXX-67921; and, "Holt Avenue (East) Reconstruction," Project No. 428-

2590-XXXX-71050 (The Project) contract agreement between the City of Pomona and All American Asphalt for additional improvements.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

- **SECTION 1.** The City Council amends the Fiscal Year 2019-20 General Fund Operating Budget by increasing General Fund revenue estimates and appropriations in the amount of \$244,972 from available Los Angeles County Prop A (Parks) Funds.
- **SECTION 2.** The City Council amends the Fiscal Year 2019-20 CIP Budget by appropriating \$244,972 of available Los Angeles County Prop A (Parks) Funds to "Street and Alley Rehabilitation Improvements District 3," Project No. 428-2590-XXXXX-71051.
- **SECTION 3.** The City Council amends the Fiscal Year 2019-20 CIP Budget by amending the Project Description for "Street and Alley Rehabilitation Improvements District 3," Project No. 428-2590-XXXXX-71051 by:
 - a. adding Washington Park Parking Lot and Sidewalk Rehabilitation, and
 - b. adding Philadelphia Avenue (between Garey Avenue to Towne Avenue) Street Rehabilitation and further east, as funds allow.
- **SECTION 4.** The City Council amends the Fiscal Year 2019-20 CIP Budget by unappropriating \$80,000 of Measure R funds from "Major Street Rehabilitation Citywide (FY 13-14 to FY 15-16)," Project No. 428-2590-XXXXX-68548;
- **SECTION 5.** The City Council amends the Fiscal Year 2019-20 CIP Budget by appropriating \$40,000 of Measure R Funds to "Street Improvements District 5," Project No. 428-2590-XXXXX-71045.
- **SECTION 6.** The City Council amends the Fiscal Year 2019-20 CIP Budget by appropriating \$40,000 of Measure R Funds to "Street Rehabilitation District 6," Project No. 428-2590-XXXXX-67921.
