

**RESOLUTION NO. 2020-11**

**A RESOLUTION OF THE CITY COUNCIL, SITTING AS THE GOVERNING BOARD OF THE CITY OF POMONA, CALIFORNIA, HOUSING AUTHORITY, AUTHORIZING THE SUBMITTAL OF A GRANT APPLICATION TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT TO FUND A FAMILY UNIFICATION PROGRAM KNOWN AS THE FOSTER YOUTH TO INDEPENDENCE (FYI) THAT WILL PROVIDE RENTAL ASSISTANCE FOR TRANSITIONAL-AGED YOUTH (TAY) FACING HOMELESSNESS OR AT-RISK OF BECOMING HOMELESS AND HAVE BEEN INVOLVED WITH THE FOSTER CARE SYSTEM.**

**WHEREAS**, On July 26, 2019, the U.S. Department of Housing and Urban Development (HUD) announced a funding opportunity for its Foster Youth to Independence (FYI) program; and

**WHEREAS**, the FYI is a program under which housing assistance is provided under the Housing Choice Voucher Program (HCV) in partnership with the Department of Children and Family Services (DCFS); and

**WHEREAS**, the Pomona Housing Authority (PHA) must submit an executed Memorandum of Understanding (MOU) between the PHA and DCFS outlining the responsibilities of the parties and evidence a commitment of resources to the FYI; and

**WHEREAS**, the DCFS will refer eligible program participants; and

**WHEREAS**, the PHA will determine program eligibility per HUD guidelines.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council, sitting as the Governing Board of the Housing Authority of the City of Pomona as follows:

**SECTION 1.** The City Council hereby authorizes the Pomona Housing Authority staff to submit a grant application to HUD for five vouchers under the FYI program;

**SECTION 2.** The City Council hereby approves entering into a MOU with the Department of Children and Family Services as required by the FYI application, subject to City Attorney review and approval;

**SECTION 3.** Authorize the City Manager/Executive Director to execute the MOU for submittal of the funding application to HUD.

**SECTION 4.** The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its approval.
