All of the speakers did not endorse the ordinance as written and expressed concerns with sustainable plans for funding, the ordinance not providing enough direction as to the role of the youth commission, overall funding for youth programs and asked the council to come back with a plan for financial support for the commission.

Mike Osoff, Parks and Recreation Manager, spoke on the history of the youth commission and struggles with past participation.

All councilmembers and the Mayor responded to comments from the speakers.

Councilmember Torres said he had expected more positive comments and spoke on still having power in an advisory position.

Councilmember Garcia spoke on the fact that no commissioners get paid. She also advised that this ordinance is a starting point for the youth.

Councilmember Ontiveros-Cole advised that the youth must do their part to make this commission successful.

Councilmember Gonzalez spoke on his experience as a youth and that even without a commission he still found ways to be involved. This commission isn't the only way to help the community.

Councilmember Preciado spoke on this ordinance as being a starting point and the importance of building relationships.

Councilmember Lustro spoke on his experience in high school on a youth commission and that it was important and he was taken seriously by the City Council.

Mayor Sandoval said he admired the youth speaking their mind and advised them that the youth commission can receive funding through Finding of Public Benefit funds. He spoke on the council not trying to prevent the youth from their own vision of what they want the commission to do. The Council provided a starting point for this commission and it can be further developed. He addressed recommendations from an email sent from a youth organizations which included that members of the commission should be equally represented for diversity.

The City Attorney advised that this cannot be included as a requirement but can be part of a recital in the vision language of the ordinance.
