MAYOR/COUNCILMEMBER COMMUNICATIONS

Mayor Sandoval asked the Pomona High School Football team to step forward in order to be recognized as being the 6 time Miramonte Champions and CIF Champions. Mayor Sandoval and Council also recognized Deputy City Clerk Genoveva Rocha for her 17 years of service to the City of Pomona.

Mayor Sandoval and the City Council recognized and spoke about retiring City Manager Linda Lowry and presented her with a Pomona Goddess and various gifts.

Mayor Sandoval asked if there were any other individuals in the public who would like to say a few words about City Manager Lowry.

Past Councilmember Cristina Carrizosa spoke on City Manager Lowry's achievements during her time in the City and wished her a well-deserved retirement.

CITY MANAGER COMMUNICATIONS

Kyle Brown, member of Clean and Green Pomona, shared with the Council that Clean and Green Pomona had received a grant to be able to purchase and plant 325 trees throughout the City of Pomona and thanked city staff for their assistance with the grant process.

Robert Santistevan, resident, shared his concern about a code violation his parents had received with regard to their fencing and its height.

Melissa Givens, representative from Pomona Area Chapter of Alpha Kappa Alpha Sorority, Inc., informed Council and the public of 2 upcoming Martin Luther King, Jr. events. The first event called a Day of Service would be taking place on January 20, 2020 at the Pomona Valley Christian Center and the second event called MLK Sunday Supper & Discussion would be taking place on January 19, 2020.

Benjamin Wood spoke on the retirement of the current Chief of Police and shared his concerns with police behavior.

Eunice Russell, resident, commended the City Council in setting up the new homeless shelter and shared her concerns with other cities not housing their own homeless and City of Pomona Page 4

Javier Flores, resident, spoke on his concerns with the newly formed Youth Commission.

M. Joyce Bakersmith, resident, presented Councilmember Steve Lustro and the Pomona Police Department with certificates of appreciation for their assistance with the Annual Cultural Festival which was held at Willie White Park. Ms. Bakersmith spoke on her concern with regard to sidewalk vendors located in the City.

Deborah Clifford, representative of the Historical Society of Pomona Valley, gave a historical story on a few of the first residents of Pomona and its surrounding areas.

Chief Olivieri introduced Pomona Police Officers Angela Torres and Diana Hernandez who are part of a newly formed full-time police unit called the Sexual Exploitation and Trafficking (SET) Team which is set to commence in January 2020. This new police unit will focus on the issues of prostitution and human trafficking in the areas of Holt Avenue and adjacent areas.

It is recommended that the City Council take the following actions:

RESOLUTION NO. 2019-203 - A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FY 2019-20 CAPITAL IMPROVEMENT PROGRAM BUDGET BY TRANSFERRING \$125,000 FROM THE GENERAL FUND CONTINGENCY LINE ITEM TO "POLICE - MAIN FACILITY ROOF REPLACEMENT," PROJECT NO. 428-2590-XXXXX-73369; and,

2) Authorize the City Manager to execute needed amendments to the following contracts with: Victorious R.E.D. (abatement), H2 Environmental (monitoring of abatement), and Letner Roofing (construction), respectively, by a total of \$86,000 for the roof and wall repairs, inspections/testing, fees, and other expenses necessary to complete this project.

A motion was made by Councilmember Lustro and seconded by Councilmember Garcia to adopt Resolution No. 2019-203 and authorize the City Manager to execute needed amendments to the following contracts with: Victorious R.E.D. Motion carried by a vote of 7-0.

19. Introduction and Adoption of an Urgency Ordinance Amending Sections .5809-26, .5809-13, .580, and .560 of the City of Pomona Zoning Ordinance pertaining to Accessory Dwelling Unit and Junior Accessory Dwelling Unit Regulations

It is recommended that the City Council introduce and adopt the following urgency ordinance:

ORDINANCE NO. 4278 - AN URGENCY ORDINANCE OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING SECTIONS .5809-26, .5809-13, .580, AND .560 OF THE CITY OF POMONA ZONING ORDINANCE PERTAINING TO ACCESSORY DWELLING UNIT AND JUNIOR ACCESSORY DWELLING UNIT REGULATIONS

Development Services Director Anita Gutierrez and Senior Planner Vinny Tam gave a presentation on Item No. 19.

Councilmember Garcia asked about the difference between an Accessory Dwelling Unit and Junior Accessory Dwelling Unit.

Senior Planner Tam explained that a Junior Accessory Dwelling Unit was limited to less than 500 square feet and that also the kitchen facility was limited. Mr. Tam also shared that the Junior Accessory Dwelling Unit needed to be constructed within the confines of an existing structure.

Councilmember Lustro shared his concern with the increase of parking within the city due to the amendment of regulations allowing multi-family homes to be able to build Accessory Dwelling Units and Junior Accessory Dwelling Units.

Councilmember Ontiveros-Cole also shared her concerns regarding the increase of parking.

Councilmember Torres asked how many applications have been received for Accessory Dwelling Units and asked about the issue of the fee being charged for expedited approval.

Senior Planner Tam stated that 185 applications had been received to date and clarified that there wasn't a specific expedited approval fee and that staff was able to work with the applicants to get their applications reviewed.

A motion was made by Councilmember Garcia and seconded by Councilmember Torres, to introduce and give first reading to Ordinance No. 4278. Motion carried by a vote of 7-0.

Mayor Sandoval requested to have Item No. 23 discussed and voted on before Item No. 20.

20. Amendment of Chapter 2, Article VII of the Pomona City Code Pertaining to the Requirements and Procedures for Procuring Supplies, Services, Equipment and Capital Improvement Contracts, and Sale of Surplus Property

It is recommended that the City Council introduce and give first reading of the following ordinance:

ORDINANCE NO. 4276 - AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING CHAPTER 2, ARTICLE VII OF THE POMONA CITY CODE PERTAINING TO THE REQUIREMENTS AND PROCEDURES FOR PROCURING SUPPLIES, SERVICES, EQUIPMENT AND CAPITAL IMPROVEMENT CONTRACTS, AND SALE OF SURPLUS PROPERTY

Finance Director Andrew Mowbray gave an overview of Item No. 20 and introduced Purchasing Manager Teresa Villa to give a presentation on Item No. 20.

Councilmember Garcia asked if this new ordinance would alleviate the delay in time needed for staff to purchase new equipment and replacement materials.

Purchasing Manager Villa indicated that this new ordinance would alleviate the current delay through the single source procurement process.

Councilmember Gonzalez asked about the bidding process and if three (3) bids will be needed in order for projects to move forward.

Ms. Villa shared that the City currently utilizes Planet Bids to announce bids that are open in the City and that all suppliers who would like to submit a bid will need to be registered through Planet Bids for consideration. She also stated that the new ordinance addresses the issue of not having three (3) valid bids and how a project may move forward with less than three bids.

A motion was made by Councilmember Preciado and seconded by Councilmember Ontiveros-Cole, to introduce and give first reading to Ordinance No. 4276. Motion carried by a vote of 6-0 with Councilmember Garcia absent.

21. Authorization of Issuance of Pension Obligation Bonds and Authorization to File Validation Action

It is recommended that the City Council adopt:

Human Resources Director Matthews gave a brief overview of Item No. 22.

Councilmember Lustro asked Ms. Matthews if the California Public Employees' Retirement System (CalPERS) was in agreement with this exception.

Human Resources Director Matthews stated that CalPERS was in agreement with this exception.

Mayor Sandoval thanked Human Resources Manager Kimberly Crews for her service to the City.

A motion was made by Councilmember Lustro and seconded by Councilmember Ontiveros-Cole, to adopt Resolution No. 2019-204. Motion carried by a vote of 6-0 with Councilmember Torres absent.

Mayor Sandoval requested to have Item No. 23 discussed and voted on before Item No. 20.

Mayor Sandoval thanked the DPOA and all those who volunteered in the Christmas Parade. Mayor Sandoval also thanked Neighborhood Services Director Benita DeFrank and staff for their work with addressing the issues of homelessness in the City and the Hope for Homes grand opening. Mr. Sandoval also thanked City staff for all that they do and wished the best and Happy Holidays for all City residents. Mayor Sandoval thanked City Manager Linda Lowry for her service to the City of Pomona.
