A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, TO AUTHORIZE THE FILING OF A HISTORIC LANDMARK APPLICATION FOR LANDMARK STATUS FOR THE POMONA CIVIC CENTER BUILDINGS TO BE CONSIDERED BY THE HISTORIC PRESERVATION COMMISSION AS REQUIRED BY THE CITY OF POMONA ZONING ORDINANCE SECTION .5809-13(E).

WHEREAS, the applicants, Mr. and Mrs. Jim and Mickey Gallivan, have submitted an application for Single Historic Landmark Designation (SHISTORIC 8195-2017) to designate as a historic landmark the Civic Center buildings including City Hall, Council Chambers, Public Library, Police Department (portions of which now house facilities for Los Angeles County Fire Department) as well as the esplanade consisting of the walkways, planters, and water fountain located on properties identified by the Los Angeles County Assessors Office as Assessor's Identification Number (AIN) 8341-009-910, 8341-012-932, and 8341-010-922; and

WHEREAS, according to the Pomona Zoning Ordinance Sec. 5809-13(E)(1)(b), the designation of nonresidential structures as historic landmarks requires the consent of the owner prior to the scheduling of a public hearing before the Historic Preservation Commission; and

WHEREAS, the City is the owner of certain improved real property, situated in the County of Los Angeles, State of California, identified by the Los Angeles County Assessors Office as AIN 8341-009-910, 8341-012-932, and 8341-010-922; and

WHEREAS, the City desires to preserve the city of Pomona's cultural, historical, and architectural heritage and resources as living parts of community life that benefit and enrich the lives of its present and future residents; and

WHEREAS, the City desires to authorize the filing of a historic landmark application for landmark status of the City of Pomona Civic Center buildings to be considered by the Historic Preservation Commission.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. The recitals set forth above are true and correct and are incorporated into this Resolution by this reference.

SECTION 2. Pursuant to the California Environmental Quality Act (CEQA) and the State CEQA Guidelines, the adoption of this resolution is exempt

from CEQA review pursuant to California Code of Regulations section 15061(b)(3), which is applicable if it can be seen with certainty that there is no possibility that the project may have a significant effect on the environment. A CEQA analysis will be included in the full application review.

SECTION 3. The City Council of the City of Pomona herby approves Resolution No. 2020-15, authorizing a historic landmark application to be considered by the Historic Preservation Commission for landmark status of the City of Pomona Civic Center buildings including City Hall, Council Chambers, Public Library, Police Department (portions of which now house facilities for Los Angeles County Fire Department) as well as the esplanade consisting of the walkways, planters, and water fountain located on City owned properties identified by the Los Angeles County Assessors Office as AIN 8341-009-910, 8341-012-932, and 8341-010-922.

SECTION 4. The City Clerk shall attest and certify to the passage and adoption of this Resolution.
