Mark Warren opposes the City imposing any local controls on rent beyond what the State has already passed

Natalie Chaidez gave updates on events at the Fairplex.

Greg Estel spoke on issue of homelessness in an alley off Gordon and Park

Javier Flores spoke on his concerns in the City.

Maria Galvan spoke on environmental racism.

Larry Ortega spoke on cell phone technology and the concern of radiation.

Arturo Jimenez spoke on the need for a community center in District 2 and the need for improvements at Tony Cerda Park.

MOTION BY COUNCILMEMBER LUSTRO, SECOND BY COUNCILMEMBER ONTIVEROS-COLE, CARRIED 7-0, to approve the entire Consent Calendar except for Item 2 which was discussed and voted in a separate motion.

1. Approve an Agreement with Cartegraph in the Amount of \$111,975 for a Software Upgrade to the City's Laboratory Information Management System (LIMS)

MOTION BY COUNCILMEMBER LUSTRO, SECOND BY COUNCILMEMBER ONTIVEROS-COLE, CARRIED 7-0, to approve the agreement with Cartegraph in the amount of \$111,975 for a software upgrade to the City's Laboratory Information System (LIMS) and authorize the City Manager to execute, all documents herein on behalf of the City, subject to review by the City Attorney.

2. Authorization to Allow an Application for Historic Landmark Status for the Pomona Civic Center Buildings

It is recommended that the City Council adopt the following resolution:

RESOLUTION NO. 2020-15 - A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AUTHORIZING THE FILING OF A HISTORIC LANDMARK APPLICATION FOR LANDMARK STATUS FOR THE POMONA CIVIC CENTER BUILDINGS TO BE CONSIDERED BY THE HISTORIC PRESERVATION COMMISSION AS REQUIRED BY THE CITY OF POMONA ZONING ORDINANCE SECTION .5809-13(E)

This item was pulled for discussion because speaker cards were submitted.

Derek Engdall said he supports the buildings but not the walkways and fountains being designated as historic. The walkways and fountains are in the process of being reimagined and the process might be hampered by a historic designation.

Mickey Gallivan said she supports the designation and gave a history on the civic center.

James Gallivan said he supports the need for the designation to respect the history of the civic center.

Venita Reynolds spoke on the importance of the Civic Center and the need for appreciating what we have.

Anita Gutierrez answered questions from the Council. All councilmembers were in support but also expressed concern about the impact of designating buildings as historical.

MOTION BY COUNCILMEMBER LUSTRO, SECOND BY COUNCILMEMBER GARCIA, CARRIED 7-0, to adopt Resolution No. 2020-15.

2) Authorize the City Manager to execute the Affordable Housing Disposition & Development Agreement and all necessary associated documents, in substantially the form submitted herein.

Kirk Pelser, Deputy City Manager, gave a brief overview on the project.

Mayor Sandoval opened the Public Hearing.

Benjamin Wood spoke on his concerns regarding long-term affordability and the need for this to be a prevailing wage project.

Mayor Sandoval closed the Public Hearing.

Kirk Pelser, Ethan Walsh, BBK attorney who specializes in affordable housing, and the developer for Jamboree Housing answered questions from the council.

The council asked questions regarding prevailing wages, leasing vs selling the land, the 55-year covenant, and priority for Pomona residents to get the affordable housing.

MOTION BY COUNCILMEMBER PRECIADO, SECOND BY COUNCILMEMBER ONTIVEROS-COLE, CARRIED 7-0, to adopt Resolution Nos. 2020-12 & 2020-16 with 3 amendments: 1) intent of the City to extend the 55 year covenant, 2) intent to have affordability last as long as possible, 3) emphasis on local hires.

MATTERS INITIATED BY CITY COUNCILMEMBERS

Councilmember Torres requested information on how to name or re-name a neighborhood and wanted an update on the wayfinding sign program.

Councilmember Lustro requested an update on billboards.

Councilmember Garcia requested council's support of HR 763.

Councilmember Preciado asked again for the adjournment in honor of Hum Bui.

Councilmember Gonzalez requested a staff research response to the Daily Bulletin article regarding equity in the city.

Mayor Sandoval asked councilmembers for interest in forming ad-committee on human trafficking.
