SUBJECT: ADOPTION OF RESOLUTION AUTHORIZING AN INTERIM

IMPLEMENTATION OF FEES PERTAINING TO THE COMMERCIAL CANNABIS PERMIT PROGRAM FOR A PERIOD OF

30 DAYS

RECOMMENDATION:

It is recommended that the City Council:

1. Approve a Resolution (Attachment No. 1) authorizing an interim implementation of fees pertaining to the Commercial Cannabis Permit Program for a period of 30 days. This matter requires a four-fifths vote (6 votes) to approve.

EXECUTIVE SUMMARY:

On March, 2, 2020, the City Council adopted fees related to the Commercial Cannabis Permit Program ("CCPP"), along with an interim implementation of these fees effective immediately for a period of 30 days. This implementation measure expired on April 2, 2020. As the fees do not go into effect until May 2, 2020, a new interim implementation is necessary to allow the City the ability to collection permit application fees.

FISCAL IMPACT: The proposed fees will offset the City's cost to administer the CCPP. The annual cost recovery is estimated between \$295,165.28 to \$543,666.32 (See Table 1 for details).

PREVIOUS COUNCIL ACTION: On March 16, 2020, the City Council approved at second reading the rescinding or amending of various ordinances prohibiting commercial cannabis in the City of Pomona. On March 2, 2020, the City Council adopted fees related to the CCPP, including an interim urgency measure implementing these fees effective immediately for a 30-day period, and approved a contract with HdL Companies as the third-party evaluator for commercial cannabis permit applications. On November 19, 2019, the City Council adopted a CCPP Overlay District, which established locations where various commercial cannabis related uses are permitted in the City. On April 1, 2019, the City Council adopted Ordinance No. 4257, which established Chapter 68 in the Pomona Municipal Code entitled "Commercial Cannabis Businesses."

ENVIRONMENTAL IMPACT: The City of Pomona, as lead agency, has conducted an environmental review on the proposed project per the California Environmental Quality Act (CEQA). The City Council will consider, as part of its recommendation, that no additional environmental review or documentation is required pursuant to statutory exemption under Sections 15060(c)(2) and 15060(c)(3) of the State Guidelines for Implementations of CEQA that pertain to activities that will not result in a direct or reasonably foreseeable indirect change to the environment and that are not defined as a project under Section 15378.

ANALYSIS:

On March, 2, 2020, the City Council adopted fees related to the Commercial Cannabis Permit Program (Attachment No. 2), as illustrated in Table 1.

Per Government Code Section 66017, these fees do not go into effect until 60 days after adoption (May 2, 2020). This provision, however, allows for the City Council to adopt an interim urgency measure based on findings of fact for public health, welfare, and safety, to implement fees immediately for a period of 30 days, which can be extend by two 30-day periods, subject to notification and public hearing. On March 2, 2020, the City Council passed an interim urgency measure for a 30-day period (Resolution No. 2020-35). This measure, however, expired on April 2, 2020. The proposed interim urgency measure would be in effect starting April 6, 2020. The City has contended with an illegal commercial cannabis market, which continues to strain law enforcement resources, and which poses a threat to public health and safety, both for the unregulated and untested products sold (some of which, such as cannabis vape cartridges, are linked to a national trend of illnesses and deaths), but also for the unknown status of building permits and licensure for such operators, creating potentially dangerous occupancy conditions. Therefore, Staff recommends adoption of an interim measure to make the CCPP fees effective immediately, for a period of 30 days, which will enable the City to implement the Commercial Cannabis Permit Program in an expeditious manner.
