**RESOLUTION NO. 2020-56 – A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FY 2019-20 CAPITAL IMPROVEMENT BUDGET BY REAPPROPRIATING \$278,138 OF SB-1 FUNDS FROM CIP PROJECTS NO. 68558 AND 68560 AND APPROPRIATING \$300,000 OF SB-1 FUND BALANCE TO “STREET PRESERVATION – LOCAL CITYWIDE (FY 19-20),” PROJECT NO. 428-2590-XXXXX-68561; AND AMENDING THE PROJECT DESCRIPTION FOR “STREET PRESERVATION – LOCAL CITYWIDE (FY 19-20),” PROJECT NO. 428-2590-XXXXX-68561.**

**WHEREAS**, the City Council desires to unappropriate \$58,138 of SB-1 funds from “Street Preservation – Local Citywide (FY17-18),” Project No. 428-2590-XXXXX-68558 and appropriate \$58,138 of SB-1 funds to “Street Preservation – Local Citywide (FY 19-20),” Project No. 428-2590-XXXXX-68561; and

**WHEREAS**, the City Council desires to unappropriate \$220,000 of SB-1 funds from “Street Preservation – Local Citywide (FY18-19),” Project No. 428-2590-XXXXX-68560 and appropriate \$220,000 of SB-1 funds to “Street Preservation – Local Citywide (FY 19-20),” Project No. 428-2590-XXXXX-68561; and

**WHEREAS**, the City Council desires to appropriate \$300,000 of SB-1 fund balance to “Street Preservation – Local Citywide (FY19-20),” Project No. 428-2590-XXXXX-68561.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**SECTION 1.** The City Council amends the FY 2019-20 CIP Budget by:

1. Unappropriating \$58,138 of SB-1 funds from “Street Preservation – Local Citywide (FY 17-18),” Project No. 428-2590-XXXXX-68558 and appropriate \$58,138 of SB-1 funds to “Street Preservation – Local Citywide (FY 19-20),” Project No. 428-2590-XXXXX-68561; and
2. Unappropriating \$220,000 of SB-1 funds from “Street Preservation – Local Citywide (FY 18-19),” Project No. 428-2590-XXXXX-68560 and appropriate \$220,000 of SB-1 funds to “Street Preservation – Local Citywide (FY 19-20),” Project No. 428-2590-XXXXX-68561; and
3. Appropriating \$300,000 of SB-1 fund balance to “Street Preservation – Local Citywide (FY 19-20),” Project No. 428-2590-XXXXX-68561; and
4. Amending the Project Description for “Street Preservation – Local Citywide (FY 19-20),” Project No. 428-2590-XXXXX-68561 to remove streets recently rehabilitated: Arroyo Avenue, Arroyo Park Drive, and La Verne Avenue, and add the following streets to this project to be completed as funds allow: 3rd Street (S Huntington Street to Oak Avenue), Dickerman Place (Cul-De-Sac to E Olive Street), Encino Place (Cul-De-Sac to E Olive Street), Klein Place (E Olive Street to End), Koolish Street (Miller Street to E Olive Street), Miller Street (S Palomares Street to Koolish Street), Shadyoak Court (Cul-De-Sac to Deerbrook Street), Pinewood Court (Cul-De-Sac to Deerbrook Street), Terrell Place (Cul-De-Sac to Deerbrook Street), Franklin Avenue (White Avenue to Park Avenue), Scenic Ridge Drive (Phillips Ranch Road to County Line), Mayfair Avenue (S Park Avenue to White Avenue), Bolivar Street (W Franklin Avenue to Mayfair Avenue),

Bainbridge Street (W Franklin Avenue to Mayfair Avenue), Hobson Court (Cul-De-Sac to Warwick Street), Warwick Street (Mayfair Avenue to Cul-De-Sac), Decker Street (Flanagan Street to End), Flanagan Street (Franklin Avenue to Fowler Street), Regene Street (7th Street to 9th Street), and 7th Street (Eleanor Street to Towne Avenue).

**SECTION 2.** The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
