

## **RESOLUTION NO. 2020-102**

### **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA AUTHORIZING THE USE OF ALL PROPERTIES WITHIN THE VEHICLE PARKING DISTRICT FOR PERMITS ASSOCIATED WITH THE “ACTIVATE POMONA” PILOT PROGRAM.**

**WHEREAS**, the City is the owner of certain unimproved real property, situated in the County of Los Angeles, State of California, more particularly described in “Exhibit A” (the “Property”), and also collectively known as the “Vehicle Parking District;”

**WHEREAS**, on Monday, June 14, 2020, the City Council of the City of Pomona approved a pilot program (“Activate Pomona”) which establishes a pathway for temporary free permits to allow businesses to expand into private and public property and to expand the definition of a home-based business, during novel coronavirus disease outbreak (“COVID-19”) recovery through December 31, 2020;

**WHEREAS**, as part of Activate Pomona, the City expects permit applications that will request the use of the Property to permit activities such as temporary art on city-owned accessory structures, the use of parking spaces for take-out and curbside pick-up, and other similar activities that assist in economic recovery during COVID-19;

**WHEREAS**, the activities allowed pursuant to this Resolution are categorically exempt from the provisions of the California Environmental Quality Act (“CEQA”) under CEQA Guidelines section 15301 (operation of existing facilities with no expansion of the use); and

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**Section 1.** Recitals. The City Council does hereby find, determine and resolve that all of the foregoing recitals are true and correct.

**Section 2.** Authorization. The City Council does further resolve, order and/or direct as follows:

- a.** The City of Pomona consents to the use of any property listed under the Vehicle Parking District (“Exhibit A”) for the following proposed activity until December 31, 2020, dependent upon a staff level review and permit issuance:

1. Use of parking spaces to facilitate curbside pick-up or take-out, or other business convenience utilizing a parking space.
  2. Use of city-owned accessory structures for placement of temporary art.
  3. Other similar uses that are consistent with the intent of Activate Pomona to facilitate economic recovery, at the discretion of the City Manager.
- b. Proposed activity shall not involve the use of any accessory structure that is not under ownership of the City of Pomona, unless consent is received from the respective owner.
- c. The authorization contained in this Section does not constitute permit issuance and any proposed activity is subject to the review and approval of the City.

**Section 3.** This Resolution shall take effect immediately upon adoption.

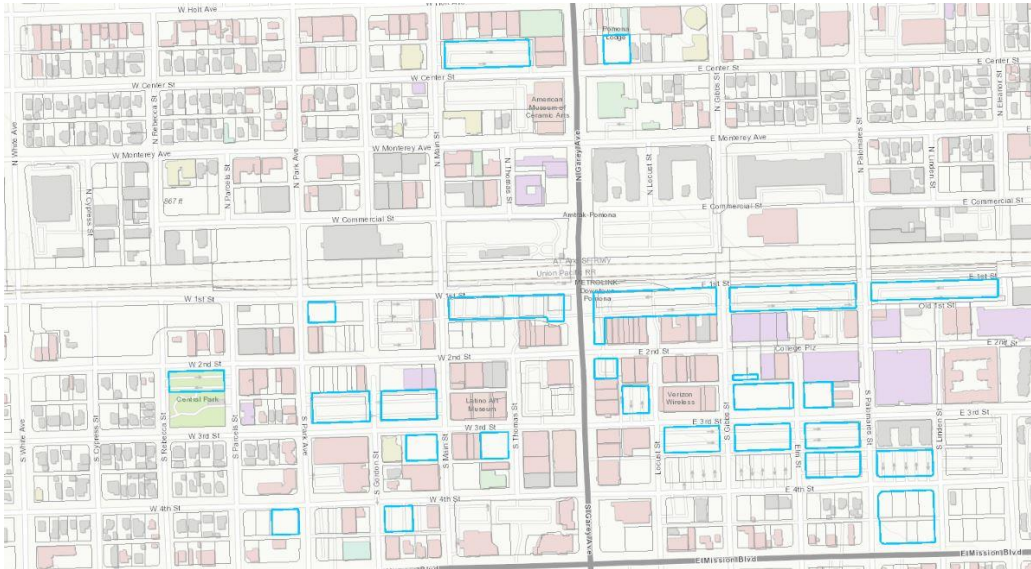
