SUBJECT: ACCEPTANCE OF THE 2018 STATE HOMELAND SECURITY GRANT PROGRAM (SHSGP) SUB-RECIPIENT AWARD IN THE AMOUNT OF \$70,199 AND ADMENDING THE FY 2020-21 OPERATING BUDGET

RECOMMENDATION:

It is recommended that the City Council take the following actions

- 1) Adopt the following resolution:

RESOLUTION NO. 2020-118 - A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA ACCEPTANCE OF THE 2018 STATE HOMELAND SECURITY GRANT PROGRAM (SHSGP) SUB-RECIPIENT AWARD IN THE AMOUNT OF \$70,199 AND AMENDING THE FY 2020-21 OPERATING BUDGET BY INCREASING REVENUE ESTIMATES AND APPROPRIATING \$1,000 IN SHSGP GRANT FUNDS (ATTACHMENT NO. 1)

- 2) Entering into a Sub-Recipient Agreement with Los Angeles County for the acceptance of \$70,199 in 2018 State Homeland Security Grant Program (SHSGP) funds, agreeing to the terms and conditions of the Sub-Recipient Agreement, (Attachment No. 2); and,
- 3) Authorizing the City Manager, or designee, to execute any and all agreements on behalf of the City, in substantially the form submitted, subject to review and approval as to form by the City Attorney.

EXECUTIVE SUMMARY:

Approval of the Proposed Resolution will increase the FY 2020-21 Operating budget and enter into a Sub-Recipient Agreement with Los Angeles County to accept the 2018 State Homeland Security Grant Program (SHSGP) funding of \$70,199 to purchase portable/handled radios.

FISCAL IMPACT:

The SHSGP funding will reimburse the City 100% (263-2090-40875-58713) of the total cost of the equipment (263-2090-52402-58713), up to the total awarded amount of \$70,199. The FY 2020-21 2018 SHSGP Grant budget was adopted in the amount of \$69,199, with the award amount being \$70,199, a budget amendment is necessary.

PREVIOUS RELATED ACTION:

The 2017 State Homeland Security Grant Program (SHSGP) Expenditure Plan was approved by the City Council on January 7, 2019.

DISCUSSION:

The Police Department has been awarded a 2018 State Homeland Security Grant (SHSGP) in the amount of \$70,199. The funding will be used to purchase handheld radios. Police Communication Technicians have been successful in maintaining a majority of the police department's 14 year old radios. However, many have been deemed not-serviceable and cannot be repaired. As a result, the Police Department has been proactively seeking grant opportunities to purchase new replacement radios.

The State Homeland Security Grant Program (SHSGP) plays a key role by providing federal funding to state and local jurisdictions, for the implementation of preparedness safety systems. The State Homeland Security Grant Program (SHSGP) provides funding to support safety equipment purchases, training, and a range of preparedness procurement activities otherwise not available due to annual financial requirements and limited resources.

Staff recommends that the City Council accept these grant funds and authorize the City Manager to execute the Grant Agreement and any other documents on behalf of the City.
