RESOLUTION NO. 2020-118 - A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA ACCEPTANCE OF THE 2018 STATE HOMELAND SECURITY GRANT PROGRAM (SHSGP) SUB-RECIPIENT AWARD IN THE AMOUNT OF \$70,199 AND AMENDING THE FY 2020-21 OPERATING BUDGET BY INCREASING REVENUE ESTIMATES AND APPROPRIATING \$1,000 IN SHSGP GRANT FUNDS

WHEREAS, the Police Department has been awarded \$70,199 in 2018 State Homeland Security Grant Program (SHSGP) funds and the Subrecipient Agreement with Los Angeles County for the acceptance of \$70,199 in 2018 SHSGP funds has been approved to fund the purchase of portable/handled radios;

WHEREAS, the FY 2020-21 Operating Budget included an appropriation of an anticipated award of \$69,199 2018 SHSGP grant funds for the 2018 State Homeland Security Grant Program (SHSGP) ; and

WHEREAS the City of Pomona was awarded \$70,199 in 2018 SHSGP Grant funds for the purchase portable/handled radios; and,

WHEREAS, the authority to accept additional 2018 SHSGP Grant funds and amend the FY 2020-21 operating budgets to allocate the grant funds to be received is vested with the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. The City Council hereby accepts the 2018 State Homeland Security Grant Program (SHSGP) award of \$70,199 and agrees to the terms and conditions of the Grant Agreement.

SECTION 2. The City Council hereby amends the FY 2020-21 Operating Budget by increasing revenue estimates and appropriating \$1,000 in SHSGP Grant funds (263-2090-XXXX-58713).

<u>SECTION 3.</u> That the City Manager, or designee, is hereby authorized to enter into the Grant Agreement on behalf of the City.

<u>SECTION 4.</u> The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall be effective immediately upon its approval.
