

RESOLUTION NO. 2020-122**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FY 2020-2021 CITY OPERATING BUDGET BY INCREASING REVENUE ESTIMATES AND APPROPRIATIONS BY \$78,280 IN STATE CENSUS 2020 EDUCATION AND OUTREACH GRANT FUNDS**

WHEREAS, Section 1008 of the Pomona City Charter allows encumbered funds to be carried to the next fiscal year, subject to approval by City Council Resolution;

WHEREAS, it is the desire of the City Council to amend the FY 2020-2021 Adopted Operating Budget for various grant funds;

WHEREAS, the State expects that cities will collaborate on outreach efforts focused on geographic areas and demographic populations referred to as “hard-to-count” (HTC) or “least likely to respond” areas;

WHEREAS, the City of Pomona has been deemed to have a number HTC areas within its jurisdiction and was allocated funding in the amount of \$91,466 to conduct 2020 Census-related education and outreach activities, and to initiate targeted outreach strategies; and

WHEREAS, the City of Pomona has developed a Census 2020 Strategic Implementation Plan, meeting the requirements as set forth by the County.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. The adopted FY 2020-2021 City Operating Budget is hereby amended to reflect changes to revenue estimates and appropriations, as follows:
