Hispanic Business owners contact us to fill out different types of documents that they cannot do due to lack of training, such as help applying for unemployment and SBA loans. Now that we are also part of the Pomona Promises group to help activate Pomona's businesses we believe to achieve this computer training is a fundamental part, especially for Hispanic businesses to comprehend and utilize the appropriate technology, softwares, and platforms to further promote and expand their business through online sales & marketing.

The use of the internet and social networks in these moments of crisis are essential to grow a business that can no longer be promoted in flyers, cards or magazines. All the paper promotions have been left in the past and in this new era only those who know how to use social networks will survive, Innovation & resilience are the exact actions for a business rise from the ashes.

Our organization has been working on training hispanic businesses to achieve better business practices for many years and we have the appropriate programs, speakers and trained teachers to carry out this great challenge of helping all Spanish-Speaking Businesses.

That is why we are asking for your financial support for the training of all businesses and to prevent them from continuing to close, because it is not only the problem of the covid-19 but the lack of understanding technological advancements that ends up affecting all those who stay working in an Ancient form.
