

RESOLUTION NO. 2020-134

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AUTHORIZING THE EXECUTION OF A MEMORANDUM OF AGREEMENT WITH THE SAN GABRIEL VALLEY COUNCIL OF GOVERNMENTS (SGVCOG), TO RECEIVE TWO HOMELESS PROGRAM GRANTS TOTALING \$264,997, AMENDING THE FY 2020-21 OPERATING BUDGET BY INCREASING REVENUE ESTIMATES AND APPROPRIATING FUNDS IN THE SAME AMOUNT

WHEREAS, in January 2020, San Gabriel Valley Council of Governments (SGVCOG) worked with San Gabriel Valley cities to propose a regional homeless program and plan to prevent and end homelessness; and,

WHEREAS, the SGVCOG allocated funding to cities within the San Gabriel Valley based on the City's population and the City of Pomona was eligible to submit grant applications and received \$264,996.25 in funding; and,

WHEREAS, the City of Pomona must enter into an Agreement with SGVCOG to accept the funding award to administer program tasks; and,

WHEREAS, Homeless Plan Implementation funding must be expended by May 31, 2022; and,

WHEREAS, Homeless Prevention and Diversion funding must be expended by June 15, 2021.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. Authorize the execution of the MOA with the SGVCOG.

SECTION 2. Authorize the acceptance of two grant awards from the SGVCOG, receiving and appropriating \$250,000 (215-1791-XXXXX-58724) to implement the City's Homeless Plan and \$14,997 (139-1791-XXXXX-58724) to implement the Prevention and Diversion Program, totaling a combined amount of \$264,997.

SECTION 3. Authorize the City Manager to execute the contracts and other documentation requested for acceptance and implementation of the grant awards, subject to approval as to form by the City Attorney.

SECTION 4. The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its approval.
