A. REQUEST:

1. APPLICATION FOR:

Conditional Use Permit to expand board and care facility

from 41 beds to 46 beds.

692 East Phillips Blvd., Pomona, California.

B ACTION:

BE IT RESOLVED by the Planning Commission as follows:

According to the procedure as set forth in Section .580, Ordinance 1466, the Planning Commission has heard this request for a Conditional Use Permit and it is hereby found and determined that this request be approved subject to the following conditions:

- 1. All requirements of all City, County and State departments and their respective codes and regulations shall be met.
- 2. The maximum capacity of the facility shall not be more than 46 beds.
- 3. The "L" shaped emergency alleyway, east of the subject facility shall remain as a portion of the subject property. The deed of the subject facility shall be subject to review and approval by the Department of Public Works prior to issuance of any City permits.
- 4. The facility shall be manned by two qualified staff members on a 24 hour basis.
- 5. Two additional qualified staff members shall be provided in the mornings and three in the evenings to provide care and therapy for the clients. Additional personnel shall be provided for cooking and domestic duties.
- 6. The structure located on 655 Alcott Street shall be reconverted to a single family Residential use, and shall be subject to review and approval of the City Planner.
- 7. A fence 6' in height shall be provided at the rear of the subject property as separation of the facility from the Alcott Street property.

Reasons for the Decision:

- 1. The proposed expansion, as conditioned, is in conformance with the General Plan and in compliance with the Zoning Ordinance.
- The proposed expansion, as conditioned, will not cause major additional adverse impact to the surrounding neighborhood.
