# MAYOR/COUNCILMEMBER COMMUNICATIONS

Councilmember Preciado reminded everyone to fill out his or her Census form as it is ending. He thanked everyone that volunteered at the Kennedy Park clean up.

Councilmember Garcia wished all teachers a Happy World Teacher Appreciation Day. She advised that on Saturday, October 17 Pomona Valley Hospital and Fairplex would be City of Pomona Page 2

hosting a free drive through flu shot clinic.

Councilmember Ontiveros-Cole thanked all that came out to volunteer at the Urban Mission for a food and clothing drive. She thanked all the pastors involved at the church.

Councilmember Lustro spoke about an upcoming tour he will be taking of the parks and facilities to look for some potential opportunities for public art in District 5. He spoke about the importance of flu shots and advised that Pomona Catholic High School will be having a free drive through flu shot clinic on October 9 sponsored by LA Care and Blue Shield of California.

Councilmember Torres thanked all community organizations that were helping with events like food drives and free flu shots. He encouraged everyone to continue to wear masks and advised that through private donation he had masks that he could provide to anyone in Pomona. He also advised that election ballots had been mailed out.

# CITY MANAGER COMMUNICATIONS

Deputy City Manager Mark Gluba reported that staff have requested that Item 4 be removed from the agenda tonight for consideration on the next council meeting agenda. Additional funding had been made available for the program and that staff wanted to appropriate all the funding at the same time.

# PUBLIC PARTICIPATION

Public Participation-In response to the global COVID 19 pandemic and in accordance with California Governor's Executive Order N 25 20 regarding the Brown Act and guidance from the California Department of Public Health on gatherings, please note that comments for Public Participation or for a specific item on the agenda were accepted by email and also were accepted live during the meeting via the chat feature on Zoom or voice. Comments received electronically via email were read into the record by the city clerk.

#### Email comments were as follows:

From Julie Mestas:

"Dear City Clerk and City Council, I'm writing tonight regarding the Vagrant situation that we have and the expense to Property Owners. We have a property in the downtown area that was broken into through the wrought iron in an alley. I could not understand how they did it, then low and behold I get a Nixel regarding thefts in Laverne and San Dimas. There were 3 people that were caught 1 man and 2 women! The 2 women were from Pomona!!! In Claremont an article came out and a percentage of the Vagrants committing crimes in the Claremont area are coming from Pomona!!! Our police are doing a great job with the limited staff they have!!! We need to fund More Police not defund them!!! I know we are living in crazy times more reason we Need more Police. It's costly for the property owners and costly to Our City as well. WE NEED MORE POLICE IN OUR CITY. Thank you, Julie M., Newton Realty"

From Ron Burcker:

"I have recently needed a repair to my sewer line lateral and was told that city ordinance Section 62-399-G requires the property owner to repair the lateral beyond the property line regardless of the cause of damage. In a time where 57 percent of Americans cannot afford a one thousand dollar surprise expense, this ordinance creates a hardship for the homeowners of Pomona. In other cities throughout California, the municipality is responsible for street maintenance and repair, including the sewer laterals up to residential property lines. I would like to propose a change to this ordinance and the maintenance responsibility of the sewer lateral pipelines. The line of ownership should be transferred from property owner to municipality at property line, not at the sewer line main. This could potentially save the community thousands of dollars that could be reinvested into our local businesses by using the city's expertise in construction project pricing. Can we consider an improvement to this ordinance for the benefit of all residents and businesses in the city of Pomona? Thank you for taking my question."

#### Live comments were as follows:

Chris Chung spoke about his concern with a proposal at 728 E Mission for a cannabis retail store and stated his complaint about the lack of proper notice from the applicant and the false signed affidavits from the applicant. He stated that city staff went ahead with a public meeting despite the fact that there was not proper notification.

Darrell Kruse spoke about how Pomona cannabis businesses were treated in the past under a different mayor and council versus other cities in California.

Jocelyn Brambila spoke about street sweeping tickets and complained about this unfair policy while many residents are still working from home. She stated she has tried to contact Councilmember Torres and the Mayor with no reply. She feels that the policy unfairly targets low income, multiple family households.

Damian Galvan, teacher and head soccer coach at Ganesha High School, spoke about the accomplishments of the boys' soccer team and girl's basketball team from last school year. He spoke about a fundraiser to pay for CIF championship rings. COVID-19 hit at the end of the soccer season last year and they were not able to fundraise for the rings or other post-season celebrations.

Mayor Sandoval advised Mr. Galvan that this item could be added to the Finding of Public Benefit item for the next council meeting.

#### MATTERS INITIATED BY CITY COUNCILMEMBERS

Councilmember Torres requested information about markings on Canfield Street. He also spoke about the alley of Willard Ave needing to be cleaned up and requested that letters be mailed out to the residents and property owners around the area asking for help. Deputy City Manager Gluba said he would have code enforcement check into the alley issue. Councilmember Torres also asked that the speed hump issue come back to a future meeting.

Councilmember Lustro requested an update from the City Attorney on the billboard issue before the end of the year.

Councilmember Ontiveros-Cole spoke about concerns for loitering and other illegal activities on Holt Avenue. She asked Chief Ellis for help in this matter.

Councilmember Garcia thanked the Code Enforcement Department for their hard work in the City.

Councilmember Preciado spoke about concerns with on and off ramps, not being cleaned up and requested an update on that. He also requested an update from Chief Ellis regarding fatal shootings that took place recently in district 4.

Mayor Sandoval also spoke about the on ramp/off ramp issue and several councilmembers joined in relaying their efforts to work with Assemblymember Rodriguez's office and CalTrans to address the cleaning of the on ramps and off ramps in Pomona. The Mayor also wanted to remind everyone to be safe and avoid large gatherings to protect those in our community, many of whom are essential workers.
