## **RESOLUTION NO. 2020-167**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA AUTHORIZING THE ACCEPTANCE OF \$310,000 IN GRANT FUNDING FROM THE STATE OF CALIFORNIA DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT FOR USE ON CITYWIDE HOUSING POLICY DEVELOPMENT AND IMPLEMENTATION; AMEND THE FY 2020-21 OPERATING BUDGET BY INCREASING REVENUE ESTIMATES AND APPROPRIATING \$310,000.

**WHEREAS**, on November 9, 2019, the City Council authorized the City Manager to seek grant funding from the State of California Department of Housing and Community Development (HCD) as part of its Building Homes and Jobs Act (SB2) program;

**WHEREAS,** the City of Pomona applied for the maximum available funding of \$310,000 to update its Housing Element, which will establish housing policy for 2021 through 2029, and to update its Zoning Code, which will establish new regulations to facilitate housing production citywide;

**WHEREAS**, on March 10, 2020, HCD issued the City a formal award letter in the amount of \$310,000; and the structure of the grant award enables the City to apply the funding towards any eligible activity between the date of the Notice of Funding Availability (March 28, 2019) and December 31, 2022;

**WHEREAS**, since the date of award, the Development Services Department has established a Pro-Housing Policy framework, and engaged in a Request for Proposals process to seek a consulting team to assist with both the Housing Element and Zoning Ordinance update; and

**WHEREAS**, the City is now in a position to revise FY 2020-21 operating budget by increase revenue estimates and appropriate the total award;

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**SECTION 1**. Authorizes the acceptance of a total award of \$310,000 in State of California Housing and Community Development SB 2 funds for use on citywide housing policy development and implementation; and to amend the FY 2020-21 operating budget by increasing revenue estimates and appropriating \$310,000 (215-1712-XXXXX-58727).

**SECTION 2.** Authorizes the City Manager to execute all agreements and any other documentation requested for acceptance of the award, distribution of the funding and operation of the subsequent agreements, subject to approval as to form by the City Attorney.
