#### 1. Mills Act Program Certificate of Appropriateness (MILLS 13887-2020)

Location: 350 E. McKinley Avenue

**Request:** A Mills Act Program, Certificate of Appropriateness (MILLS 13887-2020) for a Restoration, Rehabilitation and Preservation Plan, which includes a schedule of projects to be completed during the first ten years following execution of a Mills Act contract.

**Environmental Determination:** Pursuant to the provisions of the California Environmental Quality Act, this project meets the requirements for a Class 31 (Historical Resource Restoration/Rehabilitation), Article 19, Section 15331.

#### 2. Major Certificate of Appropriateness (MAJCOA 13258-2020)

#### Location: 420 E. Alvarado Street

**Request:** A Major Certificate of Appropriateness to demolish an existing deck area to accommodate an interior remodel and the construction of a 590 s.f. addition consisting of a new family room, laundry room, two bathrooms and a second story balcony at a property located in the R-1-6,000 (Single Family Residential) Zone and Lincoln Park Historic District.

**Environmental Determination:** Pursuant to the provisions of the California Environmental Quality Act, this project meets the requirements for a Class 1 (Existing Facilities) Categorical Exemption in that the project will not result in an increase of more than 50 percent of the floor area of the structures before the addition, or 2,500 square feet.

The Commission raised concerns with size of addition, the compatibility of the balcony, insufficient details on plans regarding materials and hardware, roof line, sizing of windows and the existing chain link fence.
