RESOLUTION NO. 2021-06

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, DESIGNATING NO PARKING AND NO STOPPING ZONES ALONG HOLT AVENUE FROM GAREY AVENUE TO EAST CITY LIMITS

WHEREAS, Section 22507 of the California Vehicle Code authorizes local agencies to restrict or prohibit the stopping, parking, or standing of vehicles on local streets during all or certain hours of the day and authorizes the establishment of neighborhood street sweeping parking programs; and

WHEREAS, Section 58-163(b) of the Pomona Municipal Code authorizes the City Council to designate no parking and no stopping zones on city streets; and

WHEREAS, Section 58-164(b)(3) of the Pomona Municipal Code prohibits parking or stopping on city streets where and when designated by the City Council; and

WHEREAS, staff has determined the cost of fabricating and installing no parking and no stopping street signs; and

WHEREAS, the City Engineer has investigated the need for parking restrictions and saidn parking restrictions can be placed on Holt Avenue from Garey Avenue to the East City Limits; and

WHEREAS, in an effort to combat the use of Holt Avenue for prostitution and related criminal activity, the City Council seeks to institute time-restricted "No Parking or No Stopping" signs along both sides of Holt Avenue from Garey Avenue to the East City Limits; and

WHEREAS, this Resolution will make it more difficult for human traffickers to conduct their illegal enterprises within the City, especially along Holt Avenue; and

WHEREAS, this will assist law enforcement in combating illegal activities within the City, especially along Holt Avenue.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

<u>SECTION 1</u>. No Parking or Stopping. Vehicles shall be prohibited from parking or stopping on both sides of Holt Avenue, from Garey Avenue to East City Limits.

<u>SECTION 2.</u> This action is based upon all written and oral evidence and testimony, the Staff Report, and the Resolution recitals, which are incorporated herein by reference.

SECTION 3. Posting Signage. The Public Works Director is hereby directed to place appropriate signs and markings giving adequate notice of the prohibitions contained within this Resolution.

SECTION 4. Severability. If any provision of this Resolution is held invalid, the remainder of this Resolution shall not be affected by such invalidity and the provisions of this Resolution are severable.

<u>SECTION 5</u>. Effective Date. This Resolution shall become effective upon its adoption.

<u>SECTION 6.</u> Certification. The City Clerk shall certify to the adoption of this Resolution.
