

RESOLUTION NO. 2021-19

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE ADOPTED FISCAL YEAR 2020-21 OPERATING BUDGET BY APPROPRIATING \$107,794 IN AVAILABLE SERIES BG BOND PROCEEDS

WHEREAS, the approved Fiscal Year 2015-16 budget included a Series AU/AV (now Series BG) bond proceed appropriation to fund a previous Zoning Code Update that was never completed. The unspent balance of \$107,794 is being requested to fund this Comprehensive Zoning Code Update under Code Studio.

WHEREAS, on June 23, 2020, the City Council authorized the City Manager to seek grant funding from the State of California Department of Housing and Community Development (HCD) as part of its Local Early Action Planning (“LEAP”) program;

WHEREAS, the City of Pomona applied for the maximum available funding of \$500,000 for updating the Pomona Zoning Ordinance and other tasks;

WHEREAS, on September 22, 2020, HCD issued the City a formal award letter in the amount of \$500,000, of which \$150,000 will be used to fund the Code Studio project;

WHEREAS, the City of Pomona also applied for the maximum available funding of \$310,000 in grant funding from HCD as part of its Building Homes and Jobs Act (SB2) program update its Zoning Code and update the Housing Element, which will establish new regulations to facilitate housing production citywide;

WHEREAS, on March 10, 2020, HCD issued the City a formal award letter in the amount of \$310,000, of which \$110,000 will be used to fund the Code Studio project;

WHEREAS, the City is now in a position to revise FY 2020-21 Operating Budget by appropriating \$107,794 in available Series BG (formally Series AU/AV) bond proceeds to cover the remaining cost of the Code Studio project;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. Authorizes the appropriation of \$107,794 from Series BG Project Fund (Account No. 435-1712-52285-0000) to cover costs associated with the Code Studio contract award.
