

**RESOLUTION NO. 2021-78****A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING APPENDIX A OF THE COMPENSATION PLAN FOR MID-MANAGEMENT LIBRARY GROUP C-2 EMPLOYEES BY ADDING THE CLASSIFICATION OF LIBRARY SUPERVISOR (60%)**

**WHEREAS**, the City Council has the authority to create, classify and assign salary scales/ranges for all City of Pomona classifications;

**WHEREAS**, the City Council has the authority to amend the staffing allocations;

**WHEREAS**, on September 16, 2019 the City Council adopted Resolution No. 2019-140 approving the terms and conditions of employment for the Compensation Plan for Mid-Management Library Group C-2 Employees (C-2 Plan);

**WHEREAS**, in order to meet department staffing needs, the City Council desires to amend Appendix A of the C-2 Plan by the actions provided herein.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Pomona as follows:

**SECTION 1.** That the City Council hereby authorizes changes to be made to Appendix A of the C-2 Plan by adding the classification as indicated below:

**SECTION 2.** That any portion of previously adopted resolutions concerning salaries inconsistent with this Resolution shall be deemed repealed.

**SECTION 3.** The actions approved herein shall become effective July 4, 2021, the first full pay period in Fiscal Year 2021-22.

**SECTION 4.** The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its adoption.
