## **RESOLUTION NO. 2021-64**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FY 2021-22 OPERATING BUDGET TO INCREASE REVENUE ESTIMATES AND APPROPRIATE PERMANENT LOCAL HOUSING ALLOCATION AND COMMUNITY DEVELOPMENT BLOCK GRANTS FUNDS

**WHEREAS**, on May 18, 2020, the City of Pomona applied for the Permanent Local Housing Allocation (PLHA) Program with the California Department of Housing and Community Development, for an amount of \$6,410,670 over a five-year period, with the first year funding amounting to \$1,068,445;

**WHEREAS,** on February 4, 2021, notification was received that the City of Pomona was awarded PLHA funding amounting to \$1,068,445 for Fiscal Year 2021-22;

**WHEREAS,** the use of PLHA Program funding is included in the Five Year PLHA Program Plan, with eligible activities including: Accessory Dwelling Units; Homebuyer Assistance; Affordable Housing Construction; Rehabilitation of Owner-Occupied Housing and up to 5% for program administration;

**WHEREAS,** on May 19, 2021, notification was also received from the Department of Housing and Community Development that the Community Development Block Grant (CDBG) funding allocation for Fiscal Year 2021-22 increased by approximately 1.5%; or an addition of \$30,111 in CDBG funds for the City of Pomona;

**WHEREAS,** there is a high demand for the City of Pomona's Housing Improvement Program, which offers grants to low-income homeowners for emergency repairs, façade improvements, and roof repair or replacement;

**WHEREAS,** based on the foregoing, the City Council desires to allocate the increase in CDBG funding to the Housing Improvement Program.

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Pomona, as follows:

**SECTION 1.** The City Council amends the (FY) 2021-22 Operating Budget to increase revenue estimates and appropriate \$1,098,556 in Permanent Local Housing Allocation and Community Development Block Grant Funds, with revenue and expenditure details provided below:
