RESOLUTION NO. 2021-79

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA APPROVING THE CLOSURE OF CITY HALL DURING THE 2021 HOLIDAY SEASON AND CANCELLATION OF 2022 MEETING DATES DUE TO CONFLICTS WITH OBSERVED HOLIDAYS

WHEREAS, Section 503 of the Pomona City Charter requires that regular meetings of the City Council be established by ordinance or resolution; and,

WHEREAS, the City Council adopted Resolution No. 2004-32, which establishes the first and third Monday of each month for regular meetings and the second Monday of each month for Study Sessions, as necessary; and,

WHEREAS, due to holidays and other scheduling conflicts that fall on the same day as regularly scheduled meetings, it would be in the best interest of the City to cancel certain regular meetings in order to allow the efficient conduct of the City's business; and,

WHEREAS, the City Council desires to authorize the closure of City Hall during the 2021 Holiday Season and cancel regular meetings as listed below in the 2022 Calendar Year that conflict with recognized City holidays or other scheduled events.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. The City Council hereby authorizes the closure of City Hall from to Wednesday, December 22, 2021 – Thursday, December 30, 2021, to avoid staffing shortages during the 2021 Holiday Season.

SECTION 2. The regular City Council Meeting scheduled for January 3, 2022, is hereby cancelled and rescheduled to Monday, January 10, 2022, to be conducted as a regular meeting of the City Council.

SECTION 3. The regular City Council Meeting scheduled for January 17, 2022, is hereby cancelled.

SECTION 4. The regular City Council Meeting scheduled for February 21, 2022, is hereby cancelled.

<u>SECTION 4</u>. The regular City Council Meeting scheduled for July 4, 2022, is hereby cancelled.

SECTION 5. The regular City Council Meeting scheduled for September 5, 2022, is hereby cancelled.

SECTION 6. All other City Council Meeting dates established in accordance with Resolution No.2004-32 remain unchanged unless otherwise rescheduled by resolution.

SECTION 7. The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its approval.
