#### **RECOMMENDATION:**

It is recommended that the City Council take the following actions:

## COMMITTEES, AND REPEALING ALL PREVIOUS BOARDS, COMMISSIONS & COMMITTEE BY-LAWS

### **EXECUTIVE SUMMARY:**

The City of Pomona currently has fourteen (14) established and active boards, commissions and committees. Each of these legislative bodies ("bodies") were created through an ordinance or requested and created by the City Council. Each of these various bodies are governed by sections of the City's Municipal Code and also through bylaws. Over the years, regulations and bylaws for these bodies have become inconsistent and inefficient. The proposed ordinance and resolution being presented to the City Council for consideration will adopt uniform practices for all city boards, commissions and committees.

### **DISCUSSION:**

The City has established a number of City boards, commissions and committees to provide for greater public participation and input into the government of Pomona. Some of these bodies have been codified in the Code of the City of Pomona, and others do not have a clear record of creation. Bylaws have been adopted over the years for the various boards, commissions and committees, but lack consistency. Many of the provisions in the bylaws are the same for all bodies, but some are different, resulting in confusion for staff and appointed commissioners and committee members. This has also resulted in inconsistency in the application of rules and inefficiency in the operation of these bodies.

Key City staff involved in the operations of boards, commissions and committees have worked in conjunction the City Attorney to propose an ordinance (Attachment No. 1 & Attachment No. 2) and resolution (Attachment No. 3) to address the issues. The City Attorney has prepared the attached draft ordinance and resolution that contain the staff recommendations for improved operation of the boards, commissions and committees, as well as related updates and clean-up changes to the Code of the City of Pomona.
