

RESOLUTION NO. 2021-83

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA RECEIVING UP TO \$207,000 FROM THE COUNTY OF LOS ANGELES WORKFORCE DEVELOPMENT, AGING AND COMMUNITY SERVICES (WDACS) FOR THE ELDERLY NUTRITION PROGRAM AND AMENDING THE FY 2021-22 OPERATING BUDGET BY INCREASING REVENUE ESTIMATES AND APPROPRIATIONS IN THE AMOUNT OF \$7,000

WHEREAS, the City's Elderly Nutrition Program continues to provide free, nutritious meals to senior adults and adults with disabilities; and,

WHEREAS, County of Los Angeles Workforce Development, Aging and Community Services (WDACS) provides reimbursement-based grant funding to the Elderly Nutrition Program and has allocated \$207,000 to the City in FY 2021-22.

WHEREAS, grant funding being received will increase revenue and expenditure estimates appropriated through an amendment to the FY 2021-22 Operating Budget. The Pomona City Charter requires budget amendments to be approved by City Council resolution; and,

WHEREAS, the FY 2021-22 Operating Budget currently includes \$200,000 in County grant revenue and expenditures for the Elderly Nutrition Program.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. The City Council accepts the County of Los Angeles WDACS allocation of \$207,000 for FY 2021-22 for the Elderly Nutrition Program.

SECTION 2. The FY 2021-22 Operating Budget shall be amended by increasing revenue estimates (226-4190-40857-00000) and appropriations (226-4190-XXXXX-00000) in the amount of \$7,000 in the Senior Nutrition Grant budget.

SECTION 3. The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
