

**RESOLUTION NO. 2021-119**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AUTHORIZING THE ACCEPTANCE OF \$912,500 IN GRANT FUNDS FOR OPERATION OF A BRIDGE HOUSING PROGRAM AT THE HOPE FOR HOME SERVICE CENTER; AMEND THE FY 2021-22 OPERATING BUDGET TO INCREASE MEASURE H REVENUE ESTIMATES BY \$127,750 AND APPROPRIATIONS BY \$91,343; DECREASE STATE HEAP REVENUE ESTIMATES BY \$384,673 AND APPROPRIATIONS BY \$377,296, AND AMENDING THE AGREEMENT WITH VOLUNTEERS OF AMERICA LOS ANGELES BY AWARDED \$863,616 TO OPERATE THE BRIDGE HOUSING PROGRAM AS THE HOPE FOR HOME SERVICES CENTER SITE OPERATOR**

**WHEREAS**, the Los Angeles Homeless Services Authority (LAHSA) is authorized to enter into contracts to allocate funding for homeless programs and projects the County; and,

**WHEREAS**, the City of Pomona (City) responded to a Request for Proposals released by LAHSA to operate a Bridge Housing Program, funding 50 beds at the Hope for Home Services Center; and,

**WHEREAS**, on October 25, 2019 LAHSA's Board of Commissioners approved the award of funding to the City; and,

**WHEREAS**, funding for this Program is made available by LAHSA through Los Angeles County Measure H Funds in the amount of \$912,500 for the term of July 1, 2021 to June 30, 2022; and,

**WHEREAS**, the City has certified that Volunteers of America Los Angeles (VOALA) is a qualified and experienced housing and social service organization which enhances services to homeless populations, and as the Hope for Home Services Center Site Operator should receive \$863,616 of the funds awarded by LAHSA to operate the Bridge Housing Program at the Hope for Home Services Center.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**SECTION 1.** Authorizes the acceptance of \$912,500 in County of Los Angeles Measure H Special Funds for the operation of a Bridge Housing Program at the Hope for Home Services Center.

**SECTION 2.** Amend FY 2021-22 Operating Budget by increasing revenue estimates by \$127,750 and appropriations by \$91,343 into 139-XXXX-XXXXX-58720 per chart below:

**SECTION 3.** Authorizes an award of \$863,616 of the funding accepted be passed-through to VOALA, as the identified Hope for Home Site Operator. This award consists of \$814,732 for program operation, including: staffing, food, facility costs, and security and also provides \$48,884 for VOALA's administrative costs to be used for operational and administrative costs for the Bridge Housing Program per the Program Agreement with LAHSA.

**SECTION 4.** Amend FY 2021-22 Operating Budget by decreasing revenue estimates by \$384,673 and decreasing appropriations by \$377,296 to reflect the omission of the State HEAP funding source in 215-XXXX-XXXXX-58720 per chart below:
