## RESOLUTION NO. 2021-114

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FY 2021-22 CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET BY CREATING TWO NEW CIP PROJECTS: 1) THE "HYDRATION STATIONS UPGRADES," PROJECT NO. 528-2590-XXXXX-71073, AND APPROPRIATING \$57,425 OF WATER FUND RESERVES TO THE NEW PROJECT; AND 2) THE "LANDSCAPE IMPROVEMENT - VARIOUS LOCATIONS," PROJECT NO. 428-2590-XXXXXX-81059, AND APPROPRIATING \$230,000 OF SAFE CLEAN WATER FUND (MEASURE W) TO THE NEW PROJECT

**WHEREAS**, the City Council is prescribed the authority by Charter of the City of Pomona to adopt and amend the Capital Improvement Program (CIP) budgets;

**WHEREAS,** a significant amount of existing drinking fountains are not Americans with Disabilities Act (ADA) Compliant or are not functioning properly;

**WHEREAS**, the "Hydration Stations Upgrades," Project No. 528-2590-XXXXX-71073 will replace and upgrade existing City drinking fountains;

**WHEREAS**, the "Landscape Improvement – Various Locations," Project No. 428-2590-XXXXX-81059 will improve various parks, City-owned lots, and medians by providing benefits of the Safe Clean Water objectives and goals. The recommended project will include improvements such as drought-tolerant and dry climate thematic landscaping features;

**WHEREAS**, the funds are available in the Water Fund and in the Safe Clean Water Fund (Measure W) to be appropriated for these two new projects; and

**WHEREAS**, the City Council desires to amend the FY 2021-22 CIP Budget by creating two new projects: "Hydration Stations Upgrades," Project No. 528-2590-XXXXX-71073, and appropriating \$57,425 of Water Fund Reserves; and "Landscape Improvement – Various Locations," Project No. 428-2590-XXXXX-81059, and appropriating \$230,000 of Safe Clean Water Fund (Measure W).

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**SECTION 1**. The City Council hereby approves creating a new CIP project, "Hydration Stations Upgrades," Project No. 528-2590-XXXXX-71073, with a transfer of \$57,425 from the Water Fund Reserves (571-2590-89951-71073) to Water CIP (528-2590-80702-71073) and appropriation to the project (528-2590-66196-71073), leaving this project partially funded, as presented in Exhibit A.

<u>SECTION 2</u>. The City Council hereby approves creating a new CIP project "Landscape Improvement – Various Locations," Project No. 428-2590-XXXXX-81059, with a transfer of\$230,000 from Safe Clean Water Fund (Measure W) (142-2590-89987-81059) to CIP (428-2590-80708-81059) and appropriation to the project (428-2590-66196-81059), leaving this project fully funded, as presented in Exhibit B.

**SECTION 3**. The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
