## **RESOLUTION NO. 2021-108**

- A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA TO RECEIVE \$300,000 FROM POMONA UNIFIED SCHOOL DISTRICT (PUSD) IN GRANT FUNDING FOR OUTDOOR AND ACTIVE YOUTH PROGRAM AND AMEND THE FY 2021-22 OPERATING BUDGET BY INCREASING REVENUE ESTIMATES AND APPROPRIATIONS IN THE AMOUNT OF \$300,000 AND ADDING ONE (1) RECREATION COORDINATOR POSITION (ATTACHMENT No. 1)
- **WHEREAS**, the City desires to provide a wide variety of specialty programs designed to address the academic, recreational and social/emotional losses PUSD students have experienced due to the COVID-19 pandemic; and
- **WHEREAS**, the City also desires to expand its After School Sports Leagues for students at PUSD's designated The Learning Connection (TLC) school sites; and
- **WHEREAS**, PUSD desires to contract with the City and has made \$300,000 in grant funding available to provide such services; and
- **WHEREAS**, the City desires to use a portion of this grant to fund one full-time staff position, several part time-staff positions, partnerships with local organizations, program supplies and admission fees associated with trips or activities; and
- **WHEREAS**, the City Council adopted the operating budget of the City of Pomona for FY 2021-22 on May 17, 2021, which included the authorized Citywide staffing allocations.
- **NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:
- **SECTION 1.** The City Council accepts the Pomona Unified School District's grant allocation of \$300,000.
- **SECTION 2.** The FY 2021-22 Operating Budget shall be amended by increasing revenue estimates in the amount of \$300,000 (215-4190-40916-58765) and an appropriation of \$300,000 (215-4190-XXXXX-58765).
- <u>SECTION 3.</u> The City Council approves amending the authorized staffing level for the Neighborhood Services Department within the Fiscal Year 2021-22 Operating Budget by adding one Recreation Coordinator.
- **SECTION 4.** The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
